# Sub: Entry & Parking Instructions during the 24th Annual Cultural Festival 'Anugoonj -2025'

24<sup>th</sup> Annual Cultural Festival 'Anugoonj-2025' is scheduled to be held from 24<sup>th</sup> February, 2025 to 26<sup>th</sup> February, 2025 in the Guru Gobind Singh Indraprastha Universityat Sector-16 C, Dwarka, New Delhi. A large number of visitors/students are likely to participate / visit the Campus during 24<sup>th</sup> Annual Cultural Festival 'Anugoonj-2025'.

All the concerned are requested to comply with the following instructions for smooth functioning of Anugoonj:-

### 1. Gates (for entry & exit) of the University have been earmarked as under:-

(a) Gate No. 02 (Main Gate)	<ul><li>* VIP / Special Guests / Special Invitee</li><li>* Faculty / Officers / Staff</li></ul>
	* Female Students
(b) Gate No. 01 (Near PRO)	* Male students Only.
(c) Gate No. 04- (Near Auditorium)	* All Outsource Staff * School Bus * University Bus

## 2. The parking arrangements for Vehicles has been carmarked as under:-

(a) For VIP / Special Guest / Special Invitee	*	D & E Block Parking Area
(b) For Faculty / Officers / Staff	*	Near Main Gate (Left Side & Right Side) Near Auditorium Block A, B & C
(c) Outsourced Staff	*	Outside Gate No. 04

3. Entry is permitted only for the students of University School of Studies & its Affiliated Institutions on the basis of valid Identity Card only.

- 4. All the teaching & non-teaching staff are requested to carry their Official I-Card & cooperate with security Personnel deployed in the Campus.
- 5. Gates for all will be closed after 4:00 PM on each day and no entry shall be allowed after that.
- 6. The vehicles of the students and visitors are not allowed inside/ outside the University Campus due to security reasons.
- 7. All Outsourced Staff are requested to park their vehicle outside Gate No. 04.
- 8. All Residents are requested not to use Gate No. 02, during peak hours of Anugooj, 2025 i.e From 11:00 AM to 8:00 PM
- 9. All invitees are requested to bring their invitation card with envelope. (Invitation Card is not transferrable)
- 10. Items such as Cameras, weapons, sticks, sharp items, hand bags, binoculars, electronic gadgets, briefcases, lighters, match boxes, liquor bottles, eigarettes, spray, eatables, water bottles etc. are not allowed inside the Venues.
- 11. Students/visitors found in inebriated/ intoxicated state or carrying liquor or other prohibited items shall be liable for strict disciplinary action as per University Act & Rules.
