## **ORDER**

The University has created Innovation and Incubation Fund (IIF) for: supporting student led pre – incubation & incubation projects; providing seed funding to the start ups created; and funding of facility creation at AIC – GGSIPU & IPU – IIF. The activities to be supported under IIF thus include: AIC – GGSIPU Host Institute Contribution; AIC – GGSIPU Facility Creation; AIC – GGSIPU Seed Fund for Start-ups; AIC – GGSIPU Running Expenditure; IPU – IIF Facility Creation; IPU – IIF Seed Fund for Start-ups; and supporting Pre incubation Projects; and Incubation Projects. Each of the activity will be built systematically and run following a well defined process. The Competent Authority has approved formation of a set of committees to review activities and recommend financial support through the fund. The functions and membership of each of the committee is as below:

A. Apex Committee – For strategy, policy and output / outcome review

The Committee would act as apex body for approving strategy, policy and methodology for implementation of all the activities identified in a well defined manner. It will also review the outputs / outcomes of the various activities pursued. The members of committee include:
