- 1. The Heading of the Article should be in Times New Roman with 14 front sizes in all Capital, Bold: Centre Aligned.
- 2. The Author's Name should be in Times New Roman with 12 font sizes in Running and Italicized, Bold: Right Aligned.
- 3. All Main Headings should be in Times New Roman with 12 font sizes in Capital; Bold, Underlined, Left Aligned.
- **4.** Part Headings should be in Times News Roman with 12 font sizes in Running; Bold, Underlined, Left Aligned.
- **5.** Sub-Part Headings should be in Times New Roman with 12 font sizes in Running; Bold, Italicized, Left Aligned.
- **6.** Sub-Sub-Part Headings should be in Times New Roman with 12 font sizes in Running; Italicized, Left Aligned.
- 7. The body should be in Times New Roman with 12 font sizes in Running; Justified.
- **8.** Paragraph line spacing should be 1.5 line spacing.
