CRITERIA FOR PARTICIPATION IN STRAY VACANCY ROUND II ONLINE COUNSELLING:

- THERE WILL BE NO FRESH REGISTRATION/ CHOICE FILLING FOR STRAY VACANCY ROUND II.
- CANDIDATE WHO HAVE REGISTERED WITH GGSIPU AND HAVE SUBMITTED CONSENT FOR STRAY VACANCY ROUND I AND HAVE NOT BEEN ALLOTTED ANY SEAT (THROUGH STATE/CENTRAL/AIQ ACROSS THE COUNTRY).
- IF A CANDIDATE IS ALLOTTED A SEAT IN STRAY ROUND II, HE/SHE HAS TO JOIN THE ALLOTTED SEAT/COLLEGE.

WHO ARE NOT ELIGIBLE FOR ALLOTMENT:

- CANDIDATE ALLOTTED/HOLDING ANY SEAT (THROUGH STATE/CENTRAL/AIQ ACROSS THE COUNTRY).
- CANDIDATES ALLOTTED A SEAT IN STRAY ROUND I AND DID NOT FOLLOW THE REQUIRED PROCEDURE i.e. PAYMENT OF PART ACADEMIC FEE OF RS. 96000/-, REPORTING AT THE ALLOTTED COLLEGE.
- WHO HAVE NOT REGISTERED IN STRAY VACANCY ROUND I.
