1. Candidates are advised to keep all their original documents & original Demand draft of requisite fee ready at the time of counseling. Without Demand Draft seat will not be allotted.

 The Rank wise Merit List of candidates will be considered for allotment of seats in 2<sup>nd</sup> Counselling

3. For seeking admission in M.Tech. Regular programme, eligibility criteria mentioned in Admission Brochure - 2025-26 may be referred.

4. Document(s) required at the time of Counseling /Admission (self-attested copy of one set of applicable documents along with original documents).

 Admission Fee in the form of Bank Demand Drafts of Rs. 23,500/- drawn in favour of Registrar, Guru Gobind Singh indraprastha University payable at Delhi and Rs. 1,23,000/- in favour of CDAC, Noida payable at Noida.

- The Fee of Rs. 23500/- includes examination fee of Rs. 3000/- and Rs. 500/- as innovation & incubation fee of GGSIPU.

- The reservation certificate should be issued from the respective state/region in which the reservation is claimed e.g. in case any candidate claims for the seat reserved for DSC category then he has to bring SC certificate issued by Govt. of NCT of Delhi and also passed his/her qualifying exam from Delhi. Conduct and Character Certificate from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer/Notary Public /Current employer (Original and One Photocopy) not more than 06 (six) months old.
- Filled appendixes (if applicable) of Admission Brochure 2025-26 of GGSIPU:
  - 1. Filled Appendix-1 (for Defence category)
  - 2. Filled Appendix-2 (for PH category)
  - 3. Filled Appendix-5 (Medical Fitness).
- In case any of the above document(s) is/are in any language other than Hindi / English, then authentic translation in English / Hindi shall have to be produced duly verified by the issuing institution / gazetted officer/(original and photocopy) by the candidate at the time of Counselling/Admission. Failure on the part of candidate to produce the requisite authentic translation may result in refusal of admission by the Admission Officer, for which only the candidate will be responsible.

• In case the Degree/certificate has been obtained from some University/Board of any other country then an equivalence certificate must be obtained prior to

attending the counselling

• The required certificate(s) for reserved categories / classes will be essential at the time of the counselling/ admission and no provisional admission shall, be admissible for want of caste/ category certificate from the local competent authority. Further, the caste/ category certificate should invariably be in the name of candidate himself/ herself and not in favour of respective parents/ guardians.

• In case of married woman applying under reserved category has to produce the caste certificate in the name of herself. Certificate in the name of husband/mother/father is not acceptable

5. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfil all the conditions prescribed for admission. Before filling-up the verification slip at the time of Counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for

the session 2025-26. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against him/her and entire fee

6. Admission will be made strictly on merit basis (Rank-wise) and counselling/admissions will stop when all the seats get filled-up.

7. The candidates are also advised, in their own interest to check the details of fee, their name, rank, programme, institute of admission etc. on Admission Slip issued to him/her by the Admission Officer before leaving the counselling hall.

8. Withdrawal of Admission: Request of withdrawal of admission shall not be entertained through post/email/fax. Candidates in person are requested to submit a prescribed withdrawal application form (appendix 11 of admission brochure) with original fee slip at Reception, B-30 Sector 62 C-DAC, Noida, till 11/08/2025, 5:00 PM. Refund will be as per university policy/admission brochure 2025-26.
