1. This is for information of all the candidates that the "Special Round of Offline Counselling" will be carried out for the <u>Seats Remained Vacant</u>. for the given below programmes

- 2. Special Round of Offline Counselling will be conducted only for "NOT ADMITTED" candidates in various Programmes. It is stated that the candidates should not be in possession of a seat (in that particular programme where one is desirous of seeking admission) as on 25/08/2025 (including who have withdrawn through online mode only). Candidates withdrawing thereafter will NOT BE TREATED as "NOT ADMITTED" candidate. Candidates who have already taken admission in the Management Quota in affiliated Institute/College shall not be considered in the Special Round of Offline Counselling.
- 3. Document required at the time SPECIAL ROUND OF OFFLINE Counselling
  - a. Candidates who have not registered earlier for MBA PROGRAMME CODE
    101 on NIC portal are required to bring DD of Rs.2,500/- Application Fee
    (Non Refundable). in favour of Registrar, Guru Gobind Singh Indraprastha
    University, payable at Delhi (FOR CAT 2024 & CMAT 2025 Qualified
    Candidates ONLY)
  - b. In addition to above Bank Draft(s) of Rs. 96,000/- towards part academic fee is required, which is mandatory at the time counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Application Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute. (FOR CAT 2024/ CMAT 2025/ CET 2025/ CUET 2025 Qualified Candidates)

NOTE: THE FEE OF Rs. 96000/- IF PAID DURING THE COURSE OF ONLINE COUNSELLING PROCESS SHALL NOT BE ADJUSTED DURING THIS ROUND. THE FEE PAID EARLIER WILL BE REFUNDED SEPARATELY. HENCE, IT IS MANDATORY TO BRING THE DEMAND DRAFT FOR OBTAINING SEAT IN THIS ROUND OF COUNSELLING.

- m. Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- 4. During the course of Special Round of Offline Counselling, the allotment of seats shall be carried out irrespective of region and category on All India basis.
- 5. The conduct of the Special Round of OFFLINE Counselling is to facilitate those candidates only who have not been able to get admission for certain reasons in the Online Counselling Process held so far.
- 6. <u>Physical presence of the candidate is mandatory at the time of Offline Counselling, except for medical reasons.</u>
- 7. During the special Round of OFFLINE Counselling, the University shall ensure that allotment of seats in respective programme in any USS/College/Institute is purely on merit basis and in accordance with CAPPING/CUTOFF determined through Online Counselling of the respective programmes/stream of respective college to ensure NO rank violation with respect to admitted candidates.
- 8. College once allotted in this Round of Counselling will not be changed subsequently.
- 9. Seats will be allotted in the order of priority i.e. CAT/CMAT/CET/CUET.
- 10. It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualifications prescribed for admission in a particular course.
