<u>Sub</u>: Invitation for Entries and Rules & Regulations – 20th Annual Sports Meet of the University

The Directorate of Students' Welfare (DSW), Guru Gobind Singh Indraprastha University, is organizing the 20th Annual Sports Meet of the University for the academic year 2025–26, from 29th – 31st October 2025.

In this regard, the Directors/Principals of all affiliated institutes/colleges are requested to motivate the students to participate and submit entries in the following sports:

The DSW reserves the right to drop an event(s) if enough entries are not received.

The procedure for submission of entry and other rules and regulations are as under:

1. Submission of Entries:

- 1.1 The entry must be submitted in the prescribed Entry Form (Annexure-1), duly signed and sealed by the Director/Principal of the institute/college, by e-mail at **sports@ipu.ac.in** on or before 8th October 2025.
- 1.2 Entries will not be entertained after the due date. The final list of entries received will be uploaded on the University website on 13th October 2025.
- 1.3 If any team withdraws from the competition after the draw has been finalized, the concerned institute/college shall face a one-year suspension from participation in that discipline (men/women) of the concerned sport.
- 1.4 Each affiliated institute/college is entitled to enter only one team/player per sport/event.

2. Eligibility Rules & Identity Card

- 2.1 Only a bonafide student, who is currently enrolled for a degree course at the Institute/College, shall be eligible to participate.
- 2.2 Each participant must carry a valid identity card issued by their institute/college. The card must include:
 - 2.2.1 A photograph of the player with their signature.
 - 2.2.2 Attestation of the photograph under the seal of the Director/Principal.
- 2.3 Participants without valid identity cards will not be allowed to compete.

3. Rules for Participants

- 3.1 No request for participation will be entertained without the Eligibility Proforma (Annexure 2).
- 3.2 All teams/athletes must wear proper playing kit of concerned sport/event.
- 3.3 Teams/participants should report at the venue at least one hour before the scheduled start of the match.
- 3.4 Each team must be accompanied by a Faculty Member Coordinator, and a Team Manager/Coach deputed by the Principal/Director.
- 3.5 The names of the Coordinator and Manager/Coach must be entered in the Eligibility Proforma (Annexure 2).
- 3.6 The Coordinator and Manager/Coach must submit the Eligibility Proforma (Annexure -2) at the venue before the match.
- 3.7 College Identity Cards duly signed by the Principal/Director must also be presented.
- 3.8 Students facing disciplinary action in their institute/college will not be allowed to participate.
- 3.9 Students can represent only 01 institute/college during the competitions in which they are enrolled.

4. Fixtures and Draw

- 4.1 All the sports/disciplines/events will be conducted on a knockout basis.
- 4.2 Fixtures will be drawn one week before the tournaments.
- 4.3 Fixtures will be uploaded on the University website under General Notices/Circulars and Sports Activities Link.
- 4.4 All concerned must regularly check University website www.ipu.ac.in for updates.
- 4.5 Matches will be played according to the official rules in force.

5. Disputes and Protests

- 5.1 Protests should only be lodged in writing on official letter head within one (1) hour of the conclusion of the match/event to which they relate, by the team representative authorized by the Principal/Director. Protests submitted beyond this time will not be entertained.
- 5.2 Any team/participant leaving the field of play under protest shall be deemed to have lost the match and forfeits the right to protest.
- 5.3 The protest should be in writing and with all details and relief sought. Recourse may be sought in writing within one (1) hour of the receiving of Jury Committee decision. The actual time of personal handover shall be governing in this context, and a copy of the submission must be countersigned as confirmation of receipt.
- 5.4 The Jury Committee shall be responsible for handling protests/settling disputes both on and off the field, and to take decisions on the referee/umpire/judge reports.
- 5.5 Referee/Umpire/Judge decisions on facts during a match/event shall be final. Breach of the rules or unjustified actions by referee/umpire/judge/scorekeeper/timekeeper/official can only give rise to a replay if the Jury Committee resolves that the consequences to be decisive for the outcome of the game.
- 5.6 The Appellate Committee shall handle recourse against the Jury Committee ruling. The decision of Appellate Committee will be final and binding.

6. Indiscipline & Misconduct

- 6.1 Any Coordinator/Manager/Coach/Player found guilty of indiscipline or misconduct will be liable for disciplinary action.
- 6.2 In case of misconduct by any player(s) or team or team official(s), the Jury Committee may disqualify the player(s)/official(s) and/or scratch the team.
- 6.3 Teams guilty of misconduct may be debarred from Inter-Collegiate competition for up to three (3) years. Such misconduct shall be reported to the concerned institute/college authorities for concurrent disciplinary action.
- 6.4 Any loss or damage to property of participants or the University will be recovered from the concerned institute/college.
