1. Criteria for evaluation of Academic /Research Score

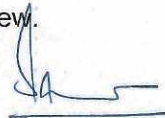
The criteria for evaluation of candidates for determining their eligibility is based on a 120 point scale criteria given in Appendix II Table-2 as per UGC Regulations 2018 for the post of Professor.

Important Instructions for the candidates:

- The candidates are advised to strictly adhere the timings for Document verification and Interview.
- Attending Document Verification is mandatory failing which candidate will not be allowed to participate in the interview.**
- The onus of the content/authenticity of the information being uploaded in the form of Academic/ Research Score shall exclusively rest with the applicant in terms of eligibility for recruitment and for subsequent selection through due process. University will not be responsible, if candidate failed in uploading the content / Academic Research, if any, which could enhance the Score.
- In case the applicant gets screened/shortlisted/selected/appointed on the basis of the credentials furnished by him/her which are, on scrutiny, found to be incorrect/inadmissible/forged /fabricated/falsified, his/her candidature shall be liable to be cancelled at any stage of the recruitment/at any time during the tenure of the service and appropriate legal action under applicable law shall be initiated against the applicant.
- The University reserves the right to modify/withdraw/cancel any communication made to the applicant. In case of any dispute arising out of such a situation, the decision of the University shall be final and binding on the applicant.
- The candidates are required to come in person for document verification alongwith following Educational/Research/Experience documents in **original as well as a set of self attested photocopy.**

Certificates lacking any of the above aspect shall not be treated as valid.
 - x. Awards (International/National Level & State-Level).
 - xi. NOC/ Vigilance Clearance from the parent department if already employed.
 - xii. Two (02) Passport Size Photographs
 - xiii. Any Other Certificate, if candidate, considered it important to support his/ her eligibility.
- vii. All documents as listed above regarding Educational Qualifications, Research and Experience should be issued on or before the last date of submission of applications.
- viii. In case of any dispute with regard to screening of the applications, the decision of the Screening Committee shall be final.
- ix. No TA/DA shall be payable for attending Document Verification/ Interview.
- x. No stay/accommodation shall be provided for attending Document Verification/ Interview.
