1. The Heading of the Article should be in Times New Roman with 14 front sizes in all Capital, Bold: Centre Aligned.
2. The Author's Name should be in Times New Roman with 12 font sizes in Running and Italicized, Bold: Right Aligned.
3. All Main Headings should be in Times New Roman with 12 font sizes in Capital; Bold, Underlined, Left Aligned.
4. Part Headings should be in Times News Roman with 12 font sizes in Running; Bold, Underlined, Left Aligned.
5. Sub-Part Headings should be in Times New Roman with 12 font sizes in Running; Bold, Italicized, Left Aligned.
6. Sub-Sub-Part Headings should be in Times New Roman with 12 font sizes in Running; Italicized, Left Aligned.
