

Legal Awareness Drive on Child Labour Law

7 May 2025



On 7th May 2025, a workshop on Basic Fundamental Rights and Child Protection Laws was successfully conducted at Government Girls Secondary School, Deputy Ganj, Delhi – 110006. The session was led by Ms. Kanika Saini, LLM (1st Year) student, USLLS, GGSIPU, with the objective of creating legal awareness among school students and educating them about their rights and responsibilities as citizens.

The workshop was designed to be engaging and informative, with complex legal concepts explained through simple, relatable, and practical examples. This approach enabled students to easily understand fundamental rights and the importance of child protection laws in their daily lives. The session encouraged curiosity and awareness about the legal system and helped students develop a basic understanding of civic responsibility.

Legal Awareness Drive on Fundamental Rights 30 July 2025



An outreach program on Fundamental Rights and Duties was conducted at Arya Vidhya Niketan as part of the internship at LEIC, with the objective of spreading constitutional awareness among young students. The session aimed to educate students about their basic rights and duties under the Indian Constitution and highlight the importance of being responsible citizens. The school was chosen to instill civic awareness at an early age and help build a more informed generation.

The session included an explanation of the meaning of law, followed by a discussion on fundamental rights and duties using real-life examples, and concluded with an interactive Q&A session. Students participated enthusiastically and showed keen interest in learning about the law. The program was well received by the school authorities and successfully fulfilled its goal of promoting civic knowledge and responsibility.

Legal Awareness Drive on Fundamental Right

18 August 2025



The group comprising Sparsh Adhikari, Vaishali Bhotia, Shivika Sharma, Aniket Sharma, and Kriti Narula conducted a community outreach programme on constitutional literacy at Government Co-Ed Senior Secondary School, Dwarka, aimed at educating Class 11 students about Fundamental Rights under the Indian Constitution. The session began with a questionnaire to assess baseline awareness, followed by an interactive discussion explaining key rights such as equality, freedom, protection from exploitation, religious and cultural rights, and constitutional remedies through relatable examples.

The students actively participated, asked questions, and connected the concepts to real-life situations, demonstrating curiosity, critical thinking, and increased confidence. The programme successfully enhanced their understanding of constitutional provisions, promoted responsible citizenship, and motivated students to learn more about democracy and legal rights. The activity also provided the group with valuable experience in teamwork, communication, and teaching while inspiring young minds to appreciate law, justice, and civic responsibility.

Legal Awareness Drive on NPHCE Scheme 15 September 2025



The outreach team conducted a community programme in a Dwarka village to raise awareness about the National Programme for Health Care of the Elderly (NPHCE), launched in 2010–11 to provide accessible, affordable, and comprehensive healthcare for senior citizens. The programme educated elderly residents on preventive, curative, rehabilitative, and mental health services available under NPHCE, including eye care, physiotherapy, chronic disease management, and tele-mental health support via helpline 14416. Residents were guided on accessing services at PHCs, CHCs, district hospitals, and tertiary centres like AIIMS.

Through direct interaction and case studies, such as the support provided to Mrs. Ganga Devi's husband for cataract treatment, the team addressed gaps in awareness, clarified procedures, and facilitated timely healthcare access. The activity highlighted the critical role of community-level guidance in improving elderly wellbeing and ensuring effective utilisation of public health services.

Legal Awareness Drive on ABPMJAY Scheme 23 September 2025



On 23rd September 2025, a community outreach program was conducted at Kakrola Village, Dwarka, Delhi by Guru Gobind Singh Indraprastha University to raise awareness about the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY). The program, conducted by Neeraj Kumar Jain, Gaurav Lakra, and Vishal, aimed to inform vulnerable families about free health coverage and the process of obtaining the Ayushman card.

The team interacted directly with community members, explained eligibility and benefits in simple language, and distributed informational material. Around 15 families were reached, with 10 individuals showing interest in registration. The outreach successfully improved awareness of government healthcare schemes and helped strengthen access to affordable healthcare for economically weaker sections.

The outreach session on "ADR as a Bridge between Legal Justice and Social Harmony" was conducted for Class 12 Humanities students at PM SHRI Kendriya Vidyalaya, Shalimar Bagh on 25 September 2025. The session introduced students to Alternative Dispute Resolution (ADR) as a tool to resolve conflicts efficiently while maintaining empathy, trust, and social harmony. Students learned about the historical roots of ADR in India, such as panchayats, and modern mechanisms like mediation and arbitration centres. The constitutional foundations of justice, including Fundamental Rights and writs, were also discussed to contextualize ADR within India's legal framework.

An interactive role-play helped students understand different ADR methods through a simple dispute scenario, demonstrating negotiation, mediation, conciliation, and arbitration. The students actively engaged with the topic, asking questions about ADR, law careers, and professional opportunities. The session successfully highlighted how conflicts can be resolved constructively through communication, cooperation, and empathy, inspiring students to see law as not just a profession but a tool for social harmony and positive change.

The students of GGSIPU conducted a session on Freedom of Expression, explaining it as a fundamental human right crucial for democracy. The session covered its legal basis under Article 19(1)(a) of the Indian Constitution and reasonable restrictions under Article 19(2). Students learned that expression includes speech, writing, creativity, and digital media, and that responsible use requires respect, critical thinking, and awareness of consequences.

The program highlighted the role and responsibilities of students in using their voices constructively—through debates, campaigns, creative projects, or civic engagement—while respecting others' dignity. Landmark cases like Romesh Thappar v. State of Madras and Shreya Singhal v. Union of India illustrated judicial protection of free speech. The session concluded by empowering students to express ideas responsibly, fostering dialogue, empathy, and active participation in school and society.

It highlighted how legal aid ensures justice for all, regardless of economic or social status, through NALSA, SLSA, and DLSA. Services include free legal representation, advice, document assistance, legal awareness programs, and dispute resolution via Lok Adalats.

Eligible beneficiaries include women, children, SC/ST communities, persons with disabilities, disaster or trafficking victims, and prisoners. Real-life examples, like a Delhi rickshaw driver receiving free legal support, demonstrated its impact. Free legal aid empowers citizens, promotes equality, and makes justice accessible, affordable, and effective for marginalized communities.







The outreach session "Promoting Digital Citizenship" educated students on safe and responsible online behaviour, cyber threats, and key provisions of the Information Technology Act, 2000. Participants learned about cyberbullying, phishing, identity theft, digital footprints, and practical safety measures like strong passwords, two-factor authentication, and privacy settings.

The session also emphasized ethical online conduct through the T.H.I.N.K. principle and a four-step action plan (PROOF, PROTECT, BLOCK, REPORT). Interactive discussions and examples helped students understand cybersecurity as both a technical and civic responsibility, promoting awareness, accountability, and safe participation in the digital world.

Legal Awareness Drive on Fundamental Right 30 October 2025




The session introduced Class 11 students to the Indian Constitution, its Fundamental Rights, Directive Principles, and key doctrines like Judicial Review, Basic Structure, and writs to show how laws and rights are protected. It also highlighted the role of Legal Services and courts in ensuring justice. The session also explored careers in law, spanning advocacy, corporate, government, judiciary, research, policy, and emerging areas like legal tech, arbitration, and legal journalism. Students learned about the roles of Advocates, Judges, AORs, JAG officers, in-house counsel, compliance officers, and policy researchers, along with higher education pathways (LL.M., Ph.D.).

The program emphasized that law today extends beyond litigation into finance, media, technology, and human rights, aiming to provide students with a comprehensive understanding of constitutional principles, the legal framework, and diverse career opportunities in the field of law.

The outreach session at Sarvodaya Kanya Vidyalaya explored the legal and human rights aspects of capital punishment in India, covering the "rarest of the rare" doctrine, procedural safeguards, clemency powers, and the risks of wrongful convictions, illustrated by *Anokhilal v. State of M.P. (2016)*. Students examined retributive versus reformative justice, recidivism data, and India's position in the global context, comparing abolitionist nations like Norway and Finland.

International norms, including UDHR Articles 3 and 5, framed the discussion on the right to life and protection from cruel treatment. The session fostered critical thinking and dialogue, encouraging students to reflect on ethical, legal, and human rights dimensions, with active engagement and appreciation for the nuanced debate.



This session aimed to empower young girls—primarily students of Class 12—by spreading awareness about cyber security, safe internet practices, and human rights in the digital space. 




A lecture on “Law in Everyday Life” was delivered to students of Classes 6 to 8. The session aimed to bridge the gap between theoretical education and practical legal awareness by explaining the importance of law in daily life. Recommendations included anti-bullying policies, reporting mechanisms, peer support, awareness programs, and teacher training.
