Sub: Permitting "new institutes" to run courses from lal-dora and extended lal-dora.

Sir.

I am directed to convey the approval of Government of NCT of Delhi to the Cabinet Decision No.1433 dated 11.08.2008 for issue of clarification regarding permitting "new institutes" to run courses from lal-dora and extended lal-dora, which is as follows:

"Some organizations running schools and providing other services like rehabilitation services through facilities located on lal-dora/extended lal-dora lands have represented stating that they are keen on running degree level courses in these buildings located on 'lal-dora' / extended 'laldora' lands. After the guidelines were circulated, there was a need to clarify what constitutes a "new institution", in view of these representations. Based on representations from stakeholders it is proposed that those organizations which fulfil the following criteria may be granted NOC to function in Lal-dora, extended Lal-dora, even though they may not have been given NOC in the past:-

The institute must be proven to be operating in the non-conforming area i.e. 'lal-dora' (i) and extended 'lal-dora' for at least two years prior to the notification of MPD-2021.

The institute must have NOC from the concerned regulatory body that permits the courses (ii)

to be run for which the NOC/affiliation is required.

The institute must furnish proof of imparting education as also copies of prospectus (iii) printed by them during the last two years in support of its claim that it offers certificate/degree courses to the students. Certificate course should be of at least one year duration and degree course should be of at least 3 years duration. At least 200 students should have benefited from these courses within the period of last two years.

The institute must have both physical and academic infrastructure required for seeking (iv) affiliation with Guru Gobind Singh Indraprastha University as per norms, in addition to the infrastructure required for the courses already been run by the institute in the said

Land use shall be governed as per the Master Plan of Delhi 2021 and Zonal Plans. (v)

The school running in non-conforming area i.e. 'lal dora', extended 'lal dora' having 2.5 acre land be considered for issue of NOC for starting B.Ed. course subject to the following terms and conditions:-

There should be Pucca approach road minimum nine metres wide. (i)

The Society should earmarked 1500 Sq.mtrs. built area separately in the school, as

per norms of NCTE.

The Society should also provide the required infrastructure and other facilities for (iii) B.Ed. course, as per norms, in addition to the infrastructure required for the courses already been run by the institute in the said premises.

The school must be proven to be operating in the 'lal dora' or extended 'lal dora' for (iv)

atleast two years prior to the notification of MPD-2021.

Land use shall be governed as per the Master Plan of Delhi 2021 and Zonal Plans. (v)

Schools proposing to start B.Ed. course must be recognized by the Directorate of (vi) Education."
