No. F. 1(35)/Statute/IPU/DRP/2008/10594.— In partial modification of Notification No. F.1(35)/Stat/IPU/DRP/2002/2674 dated 31st May 2005, and in pursuance of the provisions of Sub-section (2) of Section 26 of the Guru Gobind Singh Indraprastha University Act, 1998 (9 of 1998), the Board of Management of Guru Gobind Singh Indraprastha University, with the prior approval of Chancellor, hereby makes partial amendment in structure of Affiliation fee chargeable from the institutions while granting provisional affiliation as prescribed in sub-clause (a)(ii) of Clause 1 of Statute 26 of the University as under :—

F. 1 (35)/Stat/IPU/DRP/2002/2674.—In pursuance of the provisions of sub-section (2) of Section 26 of the Guru Gobind Singh Indraprastha University Act 1998 (9 of 1998), the Board of Management of the Guru Gobind Singh Indraprastha University, with the prior approval of the Chancellor, hereby makes the amendments in Statute 26 notified vide Notification no. F. 1 (35)/Stat/IPU/DRP/2002 dated 18-09-2002, relating to fees to be charged from institutions affiliated to the University or desirous of affiliation. Consequent upon the amendments, the revised Statute 26, as applicable from the academic session 2005-2006, is as under :—

1. A college of institution affiliated to the University or desirous of affiliation shall pay the following amount as processing fee, affiliation fees etc. in terms of the provisions of Clause 5 of Statute 24 of the Guru Gobind Singh Indraprastha University Act 1998 (9 of 1998) :—

**UNDERTAKING FOR COMPLIANCE WITH
THE CONDITIONS FOR AFFILIATION PRESCRIBED BY
THE GURU GOBIND SINGH INDRAPRASTHA UNIVERSITY, DELHI**

On behalf of (name of Society/Trust), and having been duly authorized by the Management of the (name of the Society/Trust), the undersigned gives an undertaking that the name of the Society/Trust) shall adhere to the provisions of the Act, the statutes, the ordinances and regulations of the Guru Gobind Singh Indraprastha University Act, 1998 and to comply with the standing orders and the directions of the University which includes besides other, the following salient conditions for the purpose of affiliation.

In the event of non-compliance of these provisions of the Act, the Statutes; the Ordinances, the Regulations and other standing orders/directions, the Guru Gobind Singh Indraprastha University would have right to order the suspension/withdrawal of affiliation, in part or in whole (name of the institution/college) and/or may take further necessary action in accordance with the provisions of the Guru Gobind Singh Indraprastha University Act, 1998.

1. It is managed by a Governing body constituted as specified in the Guru Gobind Singh Indraprastha University regulations.
2. It fulfils the General and programme specific norms and standards as specified in University regulations.
3. It has teachers and other employees who have the laid down qualifications and fulfill the other eligibility criteria and who are, in the number required as per the norms laid down by the University/Statutory Body.
4. It provides for teaching courses of studies and curriculum approved by the University.

5. The emoluments of the teaching and non-teaching staff of the institution/ college are in correspondence with those laid down for the corresponding posts in the University/ UGC/ Statutory Body.
6. Admissions shall be made in full compliance with admission standards and procedures as prescribed by the Government or the University.
7. Admissions in excess of the sanctioned intake per programme shall not be made under any circumstances whatsoever.
8. The Institution shall charge from the students only such tuition and other fees and charges as are prescribed by the University/ Government for a specific year.
9. The Institution shall establish adequate linkages with industrial establishments and academic institutions for enhancing both quality and relevance of programmes imparted.
10. The institution shall not conduct any full time, part time or distance education programme(s) within its premises without the specific prior permission of the university and will not conduct any programme whatsoever of any other University in the said campus. It will also not use the trademark/trade name of the university for any other admission/teaching activity/conduct of any programme at any other campus.
11. The Institution shall not without the previous permission of the University suspend instructions in any subject or course of study, where it is authorised to teach a programme or impart education.
12. The Institution shall not file a writ against the University in any court of law on any grievance without giving at least 30 days written notice to the University for redressal of the grievance. Notice period of 30 days shall be counted only from the date of receipt of the notice in the Office of the Registrar either by hand /registered post/speed post/courier.
13. The society / institute has deposited demand draft of Rs...../- against affiliation fee of programmes drawn from _____ bank dated _____ in favour of Registrar, Guru Gobind Singh Indraprastha University with accounts branch (A/b) of the University and copy of the receipt no. _____ of A/b is enclosed.
