
3. The format of submission of Research may be as under:-

- (i) Name of the Institution
- (ii) Research title
- (iii) Principal investigator and co-investigators
- (iv) Summary of the proposal (about 300 words)
- (v) Budget
- (vi) Main proposal: Background (with appropriate references), Objectives, Methodology (study design, sample size calculation, detailed workflow of the study, statistical analysis), Logistic time frame for monitoring and completion of the study.

4. The above proposal(s) should be received in the office of the DCI through the concerned State Dental Council alongwith their comments for consideration by the Committee constituted by the DCI for furtherance.

5. Your proposal(s) may kindly be received within one month from the date of issue of this letter.
