The Member Secretary welcomed all the members to the meeting. The members were briefed about the numerous activities undertaken by various schools as well as IIQAC.

The agenda was taken up as under:-

**Agenda -1: To confirm the minutes of the meeting held on December 15, 2021 at 4.00 pm in the online mode.**

**Agenda-2: To review the Action Taken Report for the points emerging from last meeting.**

- The members appreciated the progress on the actions for the discussions held in last meeting.

**Agenda-3: To report the NIRF submission for 2022 and its challenges.**

It was apprised to the members, that IIQAC has submitted the NIRF Ranking 2022 data for four branches i.e. Law, Management, Architecture and Engineering apart from the University category. It was informed that the best possible efforts have been put to collect and upload the data on various heads. The result is likely to be available in May/June 2022.

**Challenges Identified:**

- Improvement of Research output through some tight guidelines for publications as NIRF considers only Scopus and WoS publications
- Review of the Ph.D. Ordinance to improve the quantity and quality of publications
- To perform result analysis and necessary action thereof
- To leverage the MOUs for internships and placements of students
- To enhance the scholarships support to students in the campus
- To enhance patent filing by the University
- To enhance the utilization of budget for creation and augmentation of physical and academic infrastructure
- conduct of seminars and workshops on regular basis

**Agenda-4: To report the submission of AISHE data for 2021-22.**

It was apprised to the Members of the IIQAC that the data for the AISHE survey for the year 2021-22 has been uploaded on 8<sup>th</sup> March 2022. It was further informed that from this year a number of changes have been made in the uploading portal and is fully online. All members appreciated the efforts of the Cell for timely completion of the work despite hectic work due to NAAC activities.

**Agenda-5: To share the progress of other ranking systems such as Outlook iCare, Times of India and MDRA India Today for 2022.**

The members of the Cell were informed about the participation and rankings by various other agencies in the last one year, which are as follows:

Outlook iCare Survey 2022: Management was ranked at 16 among the top public management institutions in the country improving from its previous year rank of 20.

In February 2022, Times of India has ranked Management School at rank 12 among top business schools in India. The methodology used included Desk research, factual survey and perceptual rating. It was at rank 4 among 20 top business schools in North India





MDRA India Today for the year 2022 ranked GGSIPU at 12<sup>th</sup> position among the India's Best Universities – Government.

The members appreciated the progress made in the last one year but also reminded of the challenges that lie ahead to continuously improve the same.

**Agenda-6: To review the progress for 3<sup>rd</sup> Cycle of NAAC's Assessment and Accreditation of the University and plan of action for the same.**

The Member Secretary apprised the members of the IIQAC that the NAAC work is in final stages and it is likely that IIQA report would be filed within a week i.e. by March 15, 2022 and thereafter University will get 45 days to upload the data in the Self Study Report on the NAAC portal from the date of IIQA approval.


All members assured full cooperation to the NAAC team for successfully completing the above processes towards 3<sup>rd</sup> cycle of NAAC Accreditation of the University

The Self Study Report (SSR) of the University was uploaded on NAAC portal on 10 <sup>th</sup> May 2022. The Student Satisfaction Survey (SSS) has been conducted by NAAC. In addition the publication data obtained from Inflibnet has been shared by NAAC for comments, if any. The data has been accepted by University. The Data Verification and Validation (DVV) is under progress. Thereafter the Peer Team Visit will happen after the Pre-Qualifier report is received from NAAC.
