1. BACKGROUND AND PURPOSE

The leadership at Guru Gobind Singh Indraprastha University believes that in order to grow in the right direction feedback from all its stakeholders is necessary. - 2. **Information Sharing and Interaction** This parameter asks parents regarding interaction with faculty and staff of the school and availability and sharing relevant information to parents.
- 3. **Evaluation System-** The parents are asked regarding transparency of the examination and evaluation system and effectiveness of the continuous evaluation mechanisms.
- 4. Holistic Development of Student- The parents are asked about the overall growth and personality development of their ward, balance between academics, co-curricular and sports activities, and development of soft skills, awareness about social, cultural and ethical issues.
- 5. **Placement Support-** Parents are asked about relevance of curriculum for attaining next level goals (further education) and placement support provided by university.

Please Note: The feedback analysis is done only for schools where feedback is received from at least 10 or more parents.




Figure 2.1: Mean Scores of Parent's Feedback on Various Parameters














Figure 2.4: Mean Scores of Parent's Feedback on Various Parameters




