Term & Conditions:

Also, the appointee shall not have any claim whatsoever for regular appointment on any position on the basis of contract appointment or for continuing contractual appointment and may be terminated even when a regular post is lying vacant.
3. The contract appointment shall be regulated as per the Statute/Ordinance of the University.
4. The candidate should not have been convicted by any court of law.
5. No TA/DA shall be paid for attending interview.
