Eligibility qualification:

Assistant Professor in the disciplines of CSE/IT, ECE, EE & ME – Master's Degree with a first class or a equivalent grade in relevant discipline. For the Candidates not having qualification of M. Tech., a Doctoral Degree is a must for the post of Assistant Professor. Regarding NET, UGC guidelines shall be followed wherever applicable from time to time.

Terms & Conditions:

1. The appointments shall be purely on contract basis for a period of one year or till regular appointments are made. It shall be deemed to automatically come to an end on expiry of the said contract period or till a regular incumbent joins the post, whichever is earlier.

1. Separate application form is to be submitted for each post.
2. No column of application should be left blank. Strike out those columns, which are not applicable.

All applicants who are presently employed in Government/Semi Govt./Public Sector Undertaking/University/Recognized Educational Institute etc are required to submit application through proper channel or submit a no objection certificate from present employer. However, those in private employment may submit application directly.
4. Fulfillment of conditions of minimum qualification shall not necessarily entitle any applicant to be called for interview.
5. In case of large number of applicants, University reserves the right to short-listing applicants in any manner as may be considered appropriate and no reason for rejection shall be communicated.
