

Please also submit duly filled-in undertaking (enclosed as Annexure-I) and also exercise option, if any within one month from the date of issue of this circular (as per FRSR).

In case any discrepancy is observed or arises out of a dispute at any stage and/or notwithstanding anything stated in this Regulation, for any unforeseen issues arising and not covered by this Regulation, or in the event of differences of interpretation, the decision of the Hon'ble Vice-Chancellor will be final (as per clause 16 of the regulations on the subject) and will be binding on the faculty.

**The financial benefit under CAS will only be admissible on completion of the Orientation/Refresher Course. The fixation of pay of above mentioned faculties is being done from the Date of Eligibility or completion of Orientation/Refresher course whichever is later.**
