**Presentations by the Deans of University Schools
of Studies / Principal, IGIT in order to highlight
the profiles of their respective Schools/IGIT**

Prof. P.C. Sharma, Dean, University School of Biotechnology apprised the Council about the major accomplishments of the School since its inception till date. While doing so, details of the Vision and Mission of the School, the academic programmes conducted, ranking of B.Tech. programme at No.3 as per Cyber Media-Bio Spectrum, excellent laboratory facilities coupled with the state of the art labs in genomics, proteomics, DNA sequencing and Microbiology, etc. were provided. The research outputs of the faculty, the students who are taking the School on International map, development of a Microsatellite Database of all the Sequenced Eukaryotic Organisms and the proposal for the establishment of a Centre of Excellence in Biotechnology were other prominent features of his presentation.

Prof. Subhash Wadhwa, Principal, IGIT envisioned that the Institute is for "promoting women engineers towards competitive excellence" and briefed the Council as to how the IGIT is working for the attainment of academic excellence, encouragement of innovations, academic-industry synergy, development of globally acceptable engineers aside apprising the Council about the proposed future enhancements, like establishment of 'innovation society', 'industrial research & development society', 'synergy society' and 'community services society'.

Both of these presentations were perused and commended by the members of the Council.

Agenda Item No.20.4

**To consider the proposals for the academic
programmes/ training programmes that could be
started in the context of Commonwealth Games
planned to be held at Delhi in 2010.**

The members of the Council deliberated upon the likely contributions of the University in the context of the proposed Commonwealth Games to be held at Delhi in 2010. The Vice-chancellor, at the outset, referred to the programmes which have already been started/likely to be launched

soon, namely, MBA (Real Estate), Master of Prosthetics and Orthotics, Sports Physiotherapy and M.A. (Security Management).

Prof. N.K. Chaturvedi suggested that a One-Year Full Time course could be started on 'Sports Medicine'. Similarly, Dr. S.N. Maheshwari opined that a course on Hospital Management could be launched. Likewise, Dr. Ranjana Bhatia proposed that a Post Graduate Diploma in Event Management could be started. Dr. D. Malhotra, strongly felt that a course on Sports Therapy would be highly worthwhile. Further, Prof. Subhash Wadhwa observed that the University can work upon launching of a course in the area of 'Logistics'. And, Dr. Usha Mallik felt that a One Year Certificate/Diploma Course in Sports Nursing could be quite useful in the context of the planned Games.

The Council resolved to accept all of these suggestions and it resolved that the University should consider the introduction of as many programmes as possible from out of the above.

Agenda Item No. 20.5

To consider the Regulations Governing the Upgradation/Change of Branch of the students in the Engineering Programmes during the Third Semester of their Studies.

The Council considered and deliberated upon the proposed '**Regulations Governing the Upgradation/Change of Branch of the students in the Engineering Programmes during the Third Semester of their Studies**' and resolved to approve the same. The Council, however, further resolved that these Regulations shall be operative with effect from 2007-08.

Agenda Item No.20.6

To consider the Regulations Governing the Composition and Functioning of the Students Council.

'**Regulations Governing the Composition and Functioning of the Students Council**' was discussed threadbare and the Council resolved to approve the same for adoption w.e.f. Academic Session 2007-08 with the modification that the Principal, IGIT and two students representing each of the academic programme being conducted at IGIT shall also constitute the part of the composition of this Council.

To consider the case of migration in the First Semester of Five Year LL.B (Hons.) course on an extreme compassionate grounds.


