



AGENDA ITEM NO. AC 39.02: To report action taken on the proceedings of 38th meeting of the Academic Council held on 11th Feb' 2015.

The action taken report of the University on the Agenda Items of 38th meeting of the Academic Council held on 11th Feb' 2015, was presented and the members were satisfied.

- (i) M.Phil (English) Programme will help to augment the standards of research, help students to gauge their research aptitude and would provide an Academic important link between Post Graduate and Ph.D. Programmes.
- (ii) Admission to University Ph.D. Programme, after M.Phil will be governed by UGC Regulations on Ph.D. admission.
- (iii) The Scheme of examination would be made in sync with the revised Ordinance on its approval, which is also being placed before this Academic Council vide Agenda Item No.39.15.



Special Education Programme. After considering, the Council approved the new Scheme and Syllabi of Two year B.Ed. Special Education Programme to implement it from Academic Session 2015-2016. It also resolved that the Scheme of examination would be made in sync with the revised University Ordinance on its approval, which is also being placed before this Academic Council vide Agenda Item No.39.15.



AGENDA ITEM NO. AC39.11: To consider and approve the Regulations under Ordinance -12: governing Programmes leading to the Degree of Doctor of Philosophy (Ph.D.).

The Council after due deliberations approved the Regulations under Ordinance-12, governing leading to the degree of Doctor of Philosophy (Ph.D.), with the following modifications:

Sl.No.	Modifications
1	In clause (1) sub clause (vi) the line be read as: “meeting notice shall ordinarily be 3 days in advance”.
2	In clause (2) line be read as : “their requests to the concerned SRC on prescribed format”.
3	In clause (2) the line be read as : “Recognized Faculty members from affiliated colleges /institutes or approved research centres of the University shall send their applications to the DRC through proper channel in the format prescribed by Director Research & Consultancy”.
4	Clause (3) -Procedure for Admission ,sub clause (xvii) : “Conversion of Full Time Ph.D. candidature to Part Time Ph.D. candidature may be considered by School Research Committee, based on the adequate justification and recommendation of Ph.D. supervisor. However, conversion of Part Time Ph.D. candidature to full time Ph.D. candidature is not permissible”.
5	Clause (4) sub clause (vi) the line be read as : “Research Scholars holding an M.Phil degree”. Clause (4) sub clause (vi) line be read as: “any research scholar who has passed Ph.D. course work”.



AGENDA ITEM NO. 39.12: To ratify the Course Curriculum & Syllabus, Evaluation Scheme, Eligibility Criteria and Model examination question papers for new Academic Programmes i.e (i) Master of Philosophy (M. Phil.) Clinical Psychology and (ii) M.D. (Sports Medicine), as approved by the Vice Chancellor on the recommendation of the Sub-Committee of Academic Council of University School of Medical and Paramedical Health Sciences, to be implemented from Academic Session 2015-2016.


The Academic Council ratified and approved the Course Curriculum & Syllabus, Evaluation Scheme, Eligibility Criteria and Model examination question papers, of following two new Programmes:

- (i) M. Phil. (Clinical Psychology) - at PGIMER-Ram Manohar Lohia Hospital affiliated to GGSIP University. The duration of the Course will be two year, to implement it from Academic Session 2015-2016.
- (ii) Doctor of Medicine (M.D.) (Sports Medicine) to at Sports Injury Centre, VMMC & SJH affiliated to GGSIP University. The duration of the Course will be three year, to implement it from Academic Session 2015-2016.

It also resolved that the Scheme of examination would be made in sync with the revised University Ordinance on its approval, which is also being placed before this Academic Council vide Agenda Item No.39.15.

AGENDA ITEM NO. 39.15: Revision in University Ordinance 10 and 11, and repealing of Ordinance 27 from the Academic Session 2015-2016.

In compliance to the guidelines of University Grants Commission to adopt and follow the Grading System, the existing University Ordinance 10 , 11 and 27 have been reviewed. Necessary revisions have been made in the University Ordinance 10 and 11 accordingly. The Council deliberated and approved the proposed revisions in University Ordinance-10, 11 and to implement these revised University Ordinances from Academic Session 2015-2016.

The Council also approved repealing of University Ordinance -27 (deals with Master's/ Post Graduate Diploma Programmes in Annual mode of examination) as it has been covered under the revised University Ordinance -10.

AGENDA ITEM NO. 39.16: To approve the conduct of Entrance Test for admission in MCA Lateral Entry Programme from the Academic Session 2015-2016.

The Council after due deliberations approved for conduct of Entrance Test for admission in MCA Lateral Entry Programme from the Academic Session to implement it from the Academic Session 2015-2016 with the following observations:

- (i) The eligibility criteria for MCA lateral entry programme shall be as per AICTE guidelines.
- (ii) The Comment Entrance Test (CET) syllabi for MCA lateral entry programme shall be as approved by the (BOS) Board of Studies of University School of Information and Communication Technology.

The council also approved the constitution of Appellate Committee to look into the Appeal in relation to fee structure of such Institutes/Colleges located outside Delhi.
