Minutes of the Fourth Meeting of the Academic Council

Held on 11.30 a.m. on 03.06.2000

Fourth meeting of the Academic Council of the Guru Gobind Singh Indraprastha University was held at 11.30 a.m. on 03.06.2000 in the Conference Room of the University. The following were present:-

Agenda Item No. 4.1. To confirm the minutes of the Third Meeting of the Academic Council held on 13 November 1999

The minutes of the 3rd meeting of the Academic Council which were circulated vide letter dated 10 January 2000, were confirmed.

Dr. Om Vikas made certain observations on the syllabi, which the Chairman agreed to send to respective Curriculum Development Committees for consideration.

Agenda Item No. 4.2. Action Taken

The members of the Academic Council noted the action taken on the various decisions taken in the third meeting and resolved to accept the action taken report.

Agenda Item No. 4.3. To approve the proposal for creation of teaching posts in the University Teaching Departments.

After deliberation, the Academic Council approved the creation of additional 16 posts of lecturers in the scale of Rs.8000-13500 to meet the teaching requirements in various subjects in the University Teaching Departments.

Agenda Item No. 4.4. To approve lateral entry to Engineering/Architectural degree programmes for Diploma Holders

Shri P.R. Mehta – President, Council of Architecture informed the members that lateral entry to Architecture degree programme is not covered under regulation No.:GSR320 of AICTE. Therefore, the Council after deliberation approved the scheme of lateral entry only in respect of engineering degree programme for diploma holders. The eligibility criteria, mode of selection, number of seats, fee structure, reservation, etc. as mentioned in the agenda were also approved by the Council for implementation w.e.f. the ensuing academic session 2000-2001.

In case of the programmes such as Architecture or Pharmacy, the Chairman was authorised to take the decision after examination of relevant documents.

Agenda Item No. 4.5. To approve the scheme of examination and syllabi of various programmes being run in the University Teaching Departments and in the affiliated institutions.

The Academic Council approved the proposed curriculum and examination scheme in respect of the following programmes being run in the University Teaching Departments and in the self-financing affiliated institutions:-

*For adoption of the Regulations 1983 containing the entire syllabus of Bachelor of Homoeopathy & Medicine Surgery as notified by the Central Council of Homoeopathy, the Homoeopathy Degree Course (B.H.M.S.) with the prior sanction of the Central Government.

The Chairman requested the members to go through the syllabi and the examination scheme particularly of their related disciplines and send their valuable suggestions within a fortnight for consideration and implementation by the University. The Council authorised the Chairman to incorporate any changes considered necessary as a result thereof.

The Council also empowered the Vice-Chancellor to approve the Scheme of Examination and the Syllabi in respect of Bachelor of Information Technology (BIT) programme of 4 years duration as soon as the recommendation of the committee same are received.

Agenda Item No. 4.6. To approve the Ordinances and Regulations regarding recognition of teachers of self-financing (privately managed) affiliated institutions.

The Council approved the ordinance relating to recognition of teachers and the regulations covering the minimum qualifications and experience prescribed for teaching posts for various disciplines/programmes conducted in the colleges admitted to the privileges of the University.

Shri P.R. Mehta of the Council of Architecture has informed that the Indian Council of Architecture has recently adopted the revised norms of qualifications and experience for recruitment to various teaching posts for Architecture programmes. The Academic Council, therefore, resolved for adoption of the revised norms in the regulation.

Agenda Item No. 4.7. To seek the approval of the Academic Council for a panel of at least seven experts for consideration to be associated as members of the selection committee.

The members of the Council deliberated in detail and suggested experts to be included in the panels in the following subject areas to enable the Vice-chancellor to nominate three experts for the respective selection committees as per the laid down provisions:-

- (i) Mechanical Engineering
- (ii) Architecture
- (iii) Pharmacy
- (iv) Law
- (v) Education
- (vi) Homoeopathy
- (vii) Physiotherapy
- (viii) Hotel Management & Catering Technology
- (ix) Mass Communication

The Vice-Chancellor was also authorised to add any additional name(s) in the panels.

Agenda Item No. 4.8. To consider the recognition of Degree of Associate Member of Institute of Electronics and Telecommunication Engineers (AMITE) awarded by Institute of Electronics and Telecommunication Engineers, New Delhi.

The Council approved the recognition of Associate Membership of Institute of Electronics and Telecommunication Engineers (AMITE) awarded by Institute of Electronics and Telecommunication Engineers, New Delhi as equivalent to B.Tech. degree awarded by the Guru Gobind Singh Indraprastha University for the purpose of pursuing higher education in the University and for recruitment to the superior posts and services in the University.

Agenda Item No. 4.9. To apprise the Academic Council regarding efforts made by the University for the establishment of a School of Medical Sciences in Delhi.

The Council appreciated the efforts made by the University for setting up of one more school of excellence in Medical Science in Delhi for which there is an urgent need.

Dr. (Mrs) Manju Sharma, Secretary, Department of Biotechnology, Government of India appraised the Council that an association/NRI group is interested to set-up a School of Modern Medical Sciences in Delhi. The Council authorised Dr. (Mrs) Manju Sharma to interact with the concerned group of people/organisations to workout the modalities/scheme for setting-up of the School of Modern Medical Sciences in Delhi and apprise the University so that the matter may be taken-up at appropriate level.

Agenda Item No. 4.10. To approve the implementation of new scheme of examination and syllabi for the batch of students admitted in 1998-99 and 1999-2000 in Mahila Institute of Technology.

The Council approved the implementation of the proposed scheme of examination and syllabi in the Mahila Institute of Technology w.e.f. the session 2000-2001 as under:-

I Semester (To be admitted)

To follow new scheme of examination & syllabi

III Semester

Followed Old scheme upto II Semester (June, 2000). To follow new scheme from III Semester onwards

V Semester

Followed Old Scheme upto IV Semester (June, 2000)

To follow new scheme from V Semester onwards

The Council also approved the proposed scheme that the current batches of 2nd and 4th semesters admitted in Mahila Institute of Technology in August-1999 and December, 1998 respectively may be switched over to the new scheme when they resume their instructions for the 3rd & 5th semesters respectively on August 1st, 2000. The Principal of the Mahila Institute of Technology was asked to arrange for making up minor deficiencies for these students, if necessary

Agenda Item No.4.11 To approve the introduction of Part-Time Degree Courses in

- (i) Architecture &**
- (ii) Building Construction and Management**

The Council approved the introduction of proposed two part-time degree courses in Architecture and Building construction & Management w.e.f. the ensuing academic session 2000-2001. The Council authorised the Vice-Chancellor to constitute a committee to workout the details of finances, curriculum, duration, intake and fee structure etc. for these programmes. The Council also authorised the Vice-Chancellor to approve the recommendations of the Committee for implementation.

The Council also approved the creation of 6 posts of lecturers as a core faculty in the scale of Rs.8000-13500 to run these two part-time degree courses in the University w.e.f. 2000-2001.

Additional Agenda Item No.4.13 Certification regarding programmes being conducted by (i) Vastu Kala Academy and (ii) Sushant School of Art & Architecture in respect of students admitted prior to 1999

The Academic Council approved the proposal for award of the degree of Architecture subsequent to evaluation by the University in respect of the programmes being conducted in Vastu Kala Academy and the Sushant School of Art & Architecture for the students admitted prior to year 1999. The Council authorised the Vice-Chancellor to take appropriate decision on the basis of the scheme prepared by an expert committee being constituted by the President, Council of Architecture

Any Other Agenda item: To accord autonomous status to selected institutions affiliated with the University

The Vice-chancellor placed the matter before the members to consider grant of autonomous status to some institutions.

After detailed deliberations, the Council authorised the Vice-Chancellor to constitute a committee to consider various parameters for grant of autonomous status to selected and specialised institutions which are affiliated to this University, for their overall growth and development. It was decided that the committee would also devise appropriate regulations and suggest the degree of autonomy to be granted alongwith terms of reference for the autonomy.

The meeting ended with a vote of thanks to the chair.
