
Prof. Pravin Chandra, Controller of Examinations (Operations) attended the meeting as a special invitee, to elucidate the agenda for Academic/Examinations matter.

At the outset, the Vice Chancellor welcomed the members of Academic Council and expressed thanks for their continuous valuable contribution in the Academic Council of the University.

The Vice Chancellor informed the Council, that it is the matter of great pleasure, that our University has been ranked at 21st position among the Indian Universities in the first national ranking survey conducted by National Institutional Ranking Framework under the Department of Higher Education Ministry of Human Resource Development, Government of India.

The Academic Council members lauded the efforts of the Faculty, officials, staff members and students whose direct, indirect contribution has resulted that the University has been ranked at 21st position among the Indian Universities.


The Vice Chancellor also informed that the University School of Law & Legal Studies has been ranked at 10th position among the Law Colleges/Schools in the country by the prestigious survey conducted by India Today Group. The Academic Council placed on record the appreciation for the Dean and faculty members of the for University School of Law & Legal Studies for the hardwork put in by them for achieving this ranking. Referring to the University ranking, the Council authorized the Vice Chancellor to constitute a committee to workout various parameters to access the performance and quality of each University School to award them internal ranking, thus creating the opportunity for each School and its respective faculty members to contribute to develop the School.



The Vice Chancellor informed the Academic Council that the University has conducted first stage Entrance Test for MBBS Programme. Subsequent to the Orders of the Government that the admission to its MBBS Programme will be done as per the results of National Eligibility cum Entrance Test (NEET). The University will follow NEET for admission to its MBBS Programme. It will consider all those applicants as registered who have appeared in its first stage entrance examination for MBBS without charging registration fees, and seeking admission to the University's MBBS Programme through NEET, however those candidates who have not been register through its first stage exam will also be registered on the basis of NEET and seeking admission to University program. Registration fees will be charged as per the University norms.

The Academic Council congratulated the Vice Chancellor for his leadership, for achieving prestigious ranking of the University and also School of Law & Legal Studies.

Thereafter Sh. Sushil Kumar, Joint Registrar (Coordination) presented the Agenda Items.

Agenda Item No. AC 41.02: Action Taken Report on the Proceedings of 40th meeting of the Academic Council, held on 01st March, 2016 .


The action taken report on the proceedings of the respective agenda items of 40th meeting of the Academic Council, held on 01st March, 2016 was presented before the Academic Council. The Academic Council noted the actions taken and expressed its satisfaction.

In respect to Agenda Item No. AC. 40.07 related to the approval of the list of subject experts to be appointed for various purposes by the Guru Gobind Singh Indraprastha University, it was further resolved that the Vice Chancellor may further include names of the subject experts to the list as per the requirement.

Agenda Item No.AC41.03: To consider and approve the discontinuation of the Master of Journalism and Mass Communication (Weekend) Programme in the University School of Mass Communication from the forthcoming session, 2016-2017.

The Academic Council deliberated on the agenda for discontinuation of the Master of Journalism and Mass Communication (Weekend) Programme in the University School of Mass Communication from the forthcoming session, 2016-2017. The Council considered the facts that over the year number of students seeking admission has reached to a great extent subsequently increasing the expenditure much beyond approved norms of 30% revenue generated.

Hence the Council on the recommendations of School Research Committee in its meeting held on 05.04.2016, which were also approved by the Board of Studies of the School, considered and approved the discontinuation of the Master of Journalism and Mass Communication (Weekend) Programme, in the University School of Mass Communication from the forthcoming session, 2016-2017.



Agenda Item No.AC41.04 : To consider and approve the proposal for merger of the University School of Information & Communication Technology and University School of Engineering & Technology and renamed merging School as University School of Engineering and Technology.

The proposal for merger of the University School of Information & Communication Technology and University School of Engineering & Technology and renaming it as University School of Engineering and Technology was deliberated.

Programme offered by University School of Information & Communication Technology (USICT) & University School of Engineering & Technology (USET), both off and on campus are of Engineering in nature. Further the University School of Engineering & Technology is offering only off campus Programmes in affiliated institutes and does not have any on campus Programmes and thus have no faculties and infrastructure leading to difficulties in operating both the Schools separately.


Taking note of the above the Council, approved the merger of both the Schools into one within given norms of the existing structure of University Schools.

The Council further viewed that the proposed name of the merged School that the University School of Engineering & Technology reflects only programs of only Engineering in nature and does not give any information about the Programme in Information Technology and other related areas that have brought brand value to the University.

The Council authorized the Vice Chancellor to finalize the name of the merged School reflecting the nature of the Programme run by the University School as by recommended by a committee to be constituted for this purpose. The approved nomenclature of the University Schools is as below:

- (i) University School of Architecture and Planning
- (ii) University School of Basic and Applied Sciences
- (iii) University School of Bio-Technology
- (iv) University School of Chemical Technology
- (v) University School of Education
- (vi) University School of Engineering and Technology *
- (vii) University School of Environment Management
- (viii) University School of Humanities and Social Sciences
- (ix) University School of Law & Legal Studies
- (x) University School of Management Studies
- (xi) University School of Mass Communication
- (xii) University School of Medicine and Para Medical Health Sciences

* The Academic Council authorizes the Vice-Chancellor to finalize the name of the school.



Agenda Item No.AC41.05: To consider and approve the Regulation for Recognition of Teachers (Medical) framed under the provision of University Statute 18 and University Ordinance 18.

The Academic Council was apprised that five medical colleges are presently affiliated to the University and three of these colleges are offering Post Graduate Programmes. For offering the medical Programmes recognition of teachers as per the MCI norms is needed.

The recognition of medical teachers by GGSIP University was started in year 2005, subsequently the recognition and upgradation of medical teachers was done in year 2010, 2011, 2012, 2013 & 2015. In this process it was observed that there is a requirement of University Regulation consisting of detailed guidelines of the recognition process.


The Sub Committee of Academic Council constituted by the Vice Chancellor, in its meeting held on 23.02.2016 deliberated and examined the draft Regulation for Recognition of Teachers (Medical) and recommended for the adaptation of the said Regulation i.e Regulation for Recognition of Teachers (Medical).

The Council after deliberation considered and approved the University Regulation for Recognition of Teachers (Medical) framed under University Ordinance 18 read with Statute 18. The approved University Regulation for Recognition of Teachers (Medical) as approved by the Academic Council is as below:

REGULATION : Recognition of Teachers (Medical)

APPLICABILITY : All Affiliated Institutions, offering Medical Programmes, of the University including University School of Medicine and Para Medical Health Sciences.

1. "The University" shall mean Guru Gobind Singh Indraprastha University.
2. "Affiliated institutions" shall mean any institution admitted to the privileges of the University in terms of Statute 24 and Ordinance 1.
3. "University School of Medicine and Para Medical Health Sciences" shall mean School of Studies as defined in clause 1 of the Ordinance 2.
4. Teachers of the institutions offering medical programmes, affiliated to the University, shall be recognized under Statute 18 and Ordinance 18 of the University. This regulation called "Recognition of Teachers (Medical) offering Medical Programmes" applies to teachers of medical programmes.
5. For the purpose of counting the period of experience of the teachers, only regular employment period (including deputation) shall be considered, subject to the fulfillment of the regulations / decisions / directions/ communications of the Medical Council of India (M.C.I.). Inter-cadre experience shall not be counted.
6. Papers of the following nature shall be considered in consonance with regulations / decisions / directions/ communications of the Medical Council of India (M.C.I.) from time to time:
 - a. Original article



- b. Brief research communication published as an article
- c. Review articles
- d. Published Case series / reports in journals

These papers must be published / accepted in an indexed / national journal before the last date of submission of application for recognition / upgradation.

7. Recognition of teachers belonging to various appointments / cadres of the institutions, shall be as per the M.C.I. regulations and its amendments from time to time, and directions / communications/ notifications of the M.C.I. from time to time.
8. First time recognition as teacher (appointed in any cadre) by the appointing authority of the institution shall be done as per the provisions of the applicable regulations, amendments thereto, and other relevant communications in this regard by the M.C.I.
9. Upgradation of designation of all recognized teachers (equated or otherwise) shall be done as per the provisions of the applicable regulations, amendments thereto, and other relevant communications in this regard by the M.C.I.
10. Recognition of teachers (conferment of equated teaching designation) belonging to other than teaching cadre, for the first time, shall only be considered, as per MCI norms.
11. A person who is eligible to be recognized as a medical teacher shall apply to the University within six months of joining the institution in a regular position. An already recognized medical teacher who is eligible for upgradation shall also apply within six months after the due date of eligibility for upgradation i.e. four years after the date of recognition as Assistant Professor and three years after the date of recognition as Associate Professor.
12. For already recognized / equated teachers a comprehensive review of the date of upgradation of designation shall be performed by the University as per clause 15.
13. One time exemption shall be provided to specialists (teaching cadre), who have not yet applied for recognition as a medical teacher, at the appropriate level, as per MCI norms.
14. The process of recognition shall be done on a regular basis, at least once in an Academic Calendar Year.
15. The date of recognition shall be the date of eligibility for recognition at appropriate level as per MCI norms.
16. For the purpose of identifying eligible Supervisors, for Post Graduate students, from the recognized teacher of the institution, the experience shall be counted from the date of eligibility. In case of Teachers appointed by the Ministry of Health and Family Welfare, the date of eligibility shall be the date of regular appointment as Assistant Professor and in case of Specialist from the date of grant of equated designation as Assistant Professor, subject to the fulfillment of MCI requirements.
17. The University shall invite application for recognition of teachers and upgradation of recognized designation periodically. The Scrutiny Committee for scrutiny of applications shall be constituted with the approval of the Vice Chancellor.

The Report of the Scrutiny Committee, on approval of the Vice Chancellor, shall be placed before the Selection Committee formed in consonance with the Statute 18 of the University. The minutes of the Selection Committee, after approval by the Vice Chancellor shall be notified by the University.



18. The processing of new cases for recognition / upgradation of teachers (Medical), shall be done by the office of the Director, Academic Affairs.
19. Notwithstanding anything stated in this Regulation, for any unforeseen issues arising, and not covered by this Regulation, or in the event of differences of interpretation, the Vice-Chancellor may take a decision, after obtaining if necessary the opinion / advice of a Committee consisting of any of the Deans of the Schools. The decision of the Vice-Chancellor shall, however, be final.
20. This regulation is framed under Ordinance 18 read with Statute 18 of the University. In case of any conflict with the provisions of Ordinance 18 and Statute 18, the provisions of Ordinance and Statute shall prevail over this Regulation.

Agenda item No.AC41.06 : To consider and ratify the cases of students of 2014-2015 batch who have appeared for 1st semester and for reasons etc. could not study / appear in 2nd semester examination and have now opted for readmission in 2nd semester with new batch with change in examination scheme but syllabus being the same.

The scheme of examinations have changed due to the revision of University Ordinance 10, 11 & repealing of 27, but the same could not be applied in the case of student admitted to LLB course for Academic Session 2014-2015, due to non fulfillment of the attendance criteria required for each course/paper as per the provisions of Bar Council of India . The Council considered and ratified that the Ordinance at the time of admission shall be applicable in these cases.

Agenda Item No.AC41.07 : To consider and ratify the Scheme of Examination and Syllabus of Bachelor of Audiology and Speech Language Pathology (BASLP) Programme to be implemented from the Academic Session 2016-2017.

The Academic Council was apprised that the Scheme of Examination and Syllabus of Bachelor of Audiology and Speech Language Pathology (BASLP) Programme, has been framed complying the provisions of Rehabilitation Council of India(RCI).The Academic Council considered and ratified the Scheme of Examination and Syllabus of Bachelor of Audiology and Speech Language Pathology (BASLP) Programme to be implemented from the Academic Session 2016-2017.

The Scheme of Examination and Syllabus of Bachelor of Audiology and Speech Language Pathology (BASLP) Programme as approved by the Academic Council is annexed as Annexure-B of Agenda Item No. AC41.07.



Agenda Item No.AC41.08: To consider and ratify the Scheme of Examination and Syllabus of M.Sc. Nursing Cardio- Thoracic Programme to be implemented from Academic Session 2016-2017.

The Academic Council was apprised that the Scheme of Examination and Syllabus of M.Sc. Nursing Cardio-Thoracic Programme, have been framed complying the provisions of the Indian Nursing Council. The Academic Council considered and ratified the Scheme of Examination and Syllabus of M.Sc. Nursing Cardio- Thoracic Programme to be implemented from the Academic Session 2016-2017 .

The Scheme of Examination and Syllabus of M.Sc. Nursing Cardio- Thoracic Programme as approved by the Academic Council is annexed as Annexure- C of Agenda Item No. AC41.08.

Agenda Item No.AC41.09:To consider and ratify the Scheme of Examination and Syllabus of Post Graduate Courses in Ayurveda to be implemented from Academic Session 2016-2017.

The Academic Council was apprised that Chaudhary Brahm Prakash Ayurved Charak Sansthan is affiliated to the University. The BOS in its meeting held on 26.01.2016 has approved the Scheme of Examination and Syllabus of Post Graduate Courses in Ayurveda in line to the provisions of Central Council of Indian Medicine. The same was also approved by the Sub Committee of the University in its meeting held on 03.05.2016.Subsequently the recommendations were also approved by the Vice Chancellor for its implementation from the Academic Session 2016-2017.

The Council considered and ratified the Scheme of Examination and Syllabus of Post Graduate Courses in Ayurveda to be implemented from Academic Session 2016-2017.

The Scheme of Examination and Syllabus of Post Graduate Courses in Ayurveda as approved by the Academic Council is annexed as Annexure- D of Agenda Item No. AC41.09.

Agenda Item No.AC41.10: To consider and ratify the adoption of new University Ordinance for conduct and evaluation of Examination for Post Graduate (Ayurveda) Courses.




Agenda Item No.AC41.14: To consider and ratify the Scheme of Examination and Syllabus for Master of Laws (One year) (LL.M. with specialization in Criminal Justice System) w.e.f. Academic Session 2016-2017.

The University School of Law & Legal Studies is offering two specializations in its Masters of Laws(One Year LLM Programme).The specialization offered by the School are in : (i) Criminal Justice System) (ii) Gender Justice and Women Empowerment.

The Board of Studies of University School of Law and Legal Studies in its meeting held on 12th April ,2016 has approved the Scheme and Syllabus of Examinations for Master of Laws (One year) (LL.M. , specialization in (i)Criminal Justice System and (ii) Gender Justice and Women Empowerment) and same was also approved by the Sub Committee of the Academic Council of in its meeting held on 03rd May ,2016. Subsequently the recommendations were approved by the Vice Chancellor. While discussing this agenda the Academic Council resolved that the Agenda Item AC41.14 ,AC41.15 are similar and the University School of Law and Legal Studies is offering two specializations i.e. (i) Criminal Justice system and (ii) Gender Justice and Women Empowerment, its LLM Programme (One Year Duration),the proposed specialization for LLM Programmes will be implemented from the Academic Session 2016-2017.

The Council considered and ratified the scheme of examination and syllabus for Master of Laws (One year) (LL.M. specialization in (i) Criminal Justice System and (ii) Gender Justice and Women Empowerment).

Agenda Item No.AC41.15: To consider and ratify the Scheme of Examination and Syllabus for Master of Laws (One year) (LL.M. in Gender Justice and Women Empowerment) w.e.f. Academic Session 2016-2017.

The Council considered and ratified the scheme of examination and syllabus for Master of Laws (One year) (LL.M. specialization in (i) Criminal Justice System and (ii) Gender Justice and Women Empowerment).

The Dean USLLS, also informed the Council that for Non University Evaluation Scheme/Internal evaluation of the Dissertation/Project Work and Viva Voce in all LL.B. and LL.M. Programmes there used to have been a practice of engaging an External Examiner along with Internal Examiners. Recently it was pointed out by the concerned University officials that payments cannot be made to examiners for any NUES/Internal evaluation. This matter was also reviewed by the Sub Committee of the Academic Council in its meeting of 3rd May 2016 and decided to be conducted by a Board of Examiners comprising of Dean, Supervisor and senior most faculty member and two other Examiners nominated by the Academic Programme Committee of the University School of Law and Legal Studies. The Academic Council endorsed it as per the opinion of the Controller of Examination (O) who considered it a matter as has been resolved at the School level by an executive order.



Agenda Item No.AC41.16 : To consider and ratify the revised syllabus for the Ph.D. Course Work in Philosophy of Law w.e.f. Academic Session 2016-2017.

The Council was apprised that the Board of Studies of University School of Law and Legal Studies in its meeting held on 12th April, 2016 have approved the revised Syllabus for the Ph.D. Course Work in Philosophy of Law. The syllabus for same was also approved by the Sub Committee of the Academic Council of GGSIPU in its meeting held on 03rd May, 2016. Subsequently the recommendations of the Sub Committee of the Academic Council were approved by the Vice Chancellor.

The Vice Chancellor urged to all the University Schools to assess as at what interval they are revising the Course Curriculum of the Programmes conducted in their respective Schools. If the need is there, change in the Course Curriculum, will be done but simultaneously also give thought as how soon, they should change the Course Curriculum of the ongoing academic program(s) by ensuring the continuity and quality of the same.

The Academic Council considered and approved the revised syllabus for the Ph.D. Course Work in Philosophy of Law w.e.f. Academic Session 2016-2017. The revised syllabus for the Ph.D. Course Work in Philosophy of Law as approved by the Academic Council is annexed as Annexure-K of Agenda Item No.AC41.16 .



Agenda Item No.AC41.17 : To consider and approve the discontinuation of the B.Tech-MBA(Dual Degree) Programme in the University School of Management Studies from the forthcoming session, 2016-2017.

The Council was apprised that University School of Management is running B.Tech-MBA(Dual Degree) Programme since 2008. As per the UGC Gazette Notification of India dated March 2014 clarifying the running of Integrated/ Dual Degree Programmes *"Any Integrated/ Dual Degree Programme intend to offer two separate degrees with an option for an interim exit or lateral entry, the duration of the Integrated/ Dual degree Programme must not be less than the duration equal to the sum total of the prescribed duration of the two degrees that are being combined in the Integrated/ Dual Degree Programme"*

As per this notification , the School now cannot offer Integrated/ Dual Degree Programme with an exit option as its duration is less than the sum total duration of two integrated degrees School is offering. It is further added that the number of admissions in this Programme was never encouraging and has always been in the range of 5 to 15 students against the sanctioned Intake of 60 students.

This was deliberated in the Academic Programme Committee Meeting of the School and in its meeting held on January 15, 2015 it was unanimously decided to discontinue the Programme. The same was also approved by Board of Studies of USMS .

The Academic Council considered and approved the discontinuation of the B.Tech-MBA(Dual Degree) Programme of the University School of Management Studies and there would be no admission for this Programme from Academic Session 2016-17 .


Agenda Item No.AC41.18: To consider and approve the guidelines and policy for consideration of any equivalence of degree

The Academic Council deliberated and approved the proposed guidelines and policy for consideration of any equivalence of degree as below :

Guidelines for equivalence of degrees

1. The University shall not issue any equivalence certificate for degrees issued from the (admission) Academic Session 2016-2017.
2. The equivalence of degree procedure and policy for equivalence of Bachelor of Technology (Mechanical and Automation Engineering) and Bachelor of Technology (Mechanical Engineering) as approved by the academic council, shall continue for students admitted in the 1st year till the Academic Session 2015-2016.
3. The University shall issue equivalence certificates for the degrees issued before Academic Session 2016-2017 in consonance with the University decision regarding Nomenclature of degrees as per UGC regulation.
