The Board resolved to confirm the minutes of 35th meeting as circulated.

Item No. 36.2: Action taken report on the minutes of the Thirty fifth meeting held on 5th June 2007

The Board resolved to accept the Action Taken Report on the minutes of the thirty fifth meeting of the Board of Management, as submitted.

To approve re-employment of Prof. D. V. Gupta after superannuation

The Board resolved to approve the proposal to give re-employment to D V. Gupta on the standard terms and conditions. The Board, however, approved period of re-employment as one year i.e., upto 30th September 2008, in the first



Item No. 36.4:

To consider and approve the amendments in the Clauses 16.1. and 16.2 of the Statute 31 relating to manner of appointment and terms and conditions of teachers appointed by the University.

The Board considered the proposal at length and after due deliberations, the amendments in Clauses 16.1 and 16.2 of Statute 31 were approved as below, for specking the assent of the Hon'ble Chancellor.

Existing provisions in Clause 16.1 and 16.2 of Statute 31

Proposed amendment in Clause 16.1 and 16.2 of Statute 31 for approval of Board of Management

- Teachers in the permanent whole time service of the University shall retire on superannuation on completing the age of 62 years. While a teacher whose date of birth falls on any day other than the first day of the month, shall retire on superannuation on the last day of that month, one whose date of birth is the first day of a month, shall retire on superannuation on the last date of the previous month.
 - The Board of Management may, on the recommendation of the Vice-Chancellor, re-employ a distinguished superannuated teacher after he has attained the age of 62 years for a suitable period according to the guidelines framed by the UGC upto the age of 65 years, if the Board of Management is satisfied that the services of such teacher are required in the interest of the University.

16.1 Teachers in the permanent whole time service of the University shall retire on superannuation on completing the age of 65 years. While a teacher whose date of birth falls on any day other than the first day of the month, shall retire on superannuation on the last day of that month, one whose date of birth is the first day of a month, shall retire on superannuation on the last date of the previous month.

Provided further that every teacher will be assessed at the age of 62 years by a Committee chaired by the Vice Chancellor and two subject experts, to be appointed by the Vice-Chancellor; of which at least one should be from outside the University. If this Committee is satisfied that the contribution of the teacher is outstanding, he/ she shall be allowed to continue beyond the age of 62 years.

16.2 The Board of Management may, on the recommendation of the Vice-Chancellor, re-employ distinguished superannuated teacher after he has attained the age of 65 years for a suitable period according to the guidelines framed by the UGC upto the age of 70 years, if the Board of Management is satisfied that the services of such teacher are required in the interest of the University.

The Board resolved to ratify the order of suspension made by the Vice-Chancellor in respect of Col. P. K. Upmanyu, Dy. Registrar.

The Board further considered the request of Col. P. K. Upmanyu, Dy. Registrar for revoking the suspension. The members were of the opinion that since the crime branch is expected to file the chargesheet within 90 days, which period is going to end shortly, the Vice-Chancellor may take decision in the matter taking into consideration the extent to which Col. P. K. Upmanyu is involved, as emerges from the chargesheet.
