Item No. 5.4: To consider delegating the power of Board of Management to the Vice-Chancellor for investment of surplus fund beyond Rs. I lakh

The Board resolved to authorise the Vice-Chancellor to take day to day investment decisions, for investments in nationalised banks based on the recommendations of the Investment Committee, constituted by the Vice-Chancellor.

Item No. 5:5: Affiliation of new institutions/programmes

The Board noted the list of the self-financing institutions, who have been accorded approval for the year 1999-2000 for conduct of various programmes, which included B. Tech., B. Arch., B. Pharma, B. Physiotherapy, BBA, BCA, MBA, MCA, B.Ed., LLB (Hons.) and Bachelor in Hotel Management & Catering Technology.

Item No. 5.6: Approval of ordinance relating to examination, evaluation & declaration of results

The Board resolved to approve the ordinance relating to examination, evaluation and declaration of results, with the following modification.

- The weightage to end semester examination for university teaching departments may be retained as 50%; but for affiliated institutions, it should be kept at 70%. Accordingly, minimum weightage for two terminal tests for affiliated institutions will be 15% instead of 30% as laid down for University Teaching Departments.
- 2. The Principals/ Directors of the affiliated institutions may be given the power. for condonation of attendance of 5% instead of Deans in respect of the candidates studying in affiliated institutions.
- 3. In clause 10(d), in the case of non availability of an external examiner, an appropriate board of examiners will be constituted by the Dean.

The ordinance duly modified is enclosed as annexure -'A'.

Item No. 5.7: Relaxation in the age limit for making appointments on deputation.

The Board did not approve the proposal for relaxation in the age limit for making appointments on deputation, considering the instructions of the Govt. of India in the matter.
