Item No. 7.5:

To approve the ordinance relating to maintenance and enforcement of discipline among the students of the university and those of colleges/ institutions affiliated to the University.

The Board resolved to approve the ordinance as per Annexure 'B'.

Item No. 7.6: To approve the regulations in regard to the Leave Rules for Teachers of the University.

The Board resolved to approve the regulation in regard to the Leave Rules for teachers of the University as per Annexure 'C'.

Item No. 7.7: To approve the scheme of Medical facilities and reimbursement of medical expenses.

The scheme was deliberated in detail and it was resolved to approve the same with the following modifications:-

decided that scheme relating to the various services/ procedures etc. in respect of other private hospitals on panel for general treatment may be regulated as per St.

Stephens hospital rates, as approved by Government of Delhi.

(ii) In respect of clause 7, facility for joint declaration where both the spouses are in the employment of the Government/ Government undertaking, it was decided that the declaration for claiming such benefit from the office of either of one spouse must be obtained at the initial stage. However, this declaration can be changed with the prior approval of the competent authority.

(iii) <u>Credit Cards</u>: Under the clause 8 (credit cards) the scheme was approved subject to the condition that the amount will be reimbursed to the extent of Rs. 750/- per annum for credit cards for employee only.

(iv) The medical facilities may be extended to the employees on contract basis who are in continuous contract for a period of more than one year.

The regulations incorporating the approved scheme is enclosed as Annexure -'D'.

Item No. 7.8: Setting up of a Development Corpus Fund of Guru Gobind Singh Indraprastha University.

The Board recorded its appreciation of the scheme and felt that it may serve as a model subsequent to its successful implementation.
