At the outset, the Vice Chancellor, Prof. Mahesh Verma welcomed the Hon'ble Lt. Governor, Delhi/ Hon'ble Chancellor, GGSIP University and other distinguished members of the University Court. Thereafter, the Agenda Items of the meeting were taken up with the permission of the Hon'ble Chancellor.

Agenda Item No. 13.01: To confirm the minutes of Twelfth (12th) meeting of the Court held on 29.09.2022.

The minutes of the Twelfth (12th) meeting of the Court of GGSIP University held on 29.09.2022 was circulated vide F.No. GGSIPU/Coord./12th Court/2022/346 dated 17.11.2022 to all members of the Court. Since no observation(s) / comment(s) were received, the minutes were considered as approved.

Agenda Item No. 13.02: Action Taken Report on the minutes of the Twelfth (12th) meeting of the Court held on 29.09.2022.

The Court members noted the action taken report on the minutes of the Twelfth meeting of the Court held on 29.09.2022.

It was mentioned that the University has started courses on foreign languages. The University should also consider new courses on Local Regional Languages. Prof. Vivek Sachdeva mentioned that the proposals for two regional languages (Punjabi and Urdu) are under process and a component of Tamil Literature in English Translation has been planned to add in the course curriculum of Masters of Arts (English) Programme.

The Hon'ble Chancellor and other members approved the action taken on all agenda items of the Twelfth meeting of the Court.

Agenda Item No. 13.03: To apprise the members about the NAAC Accreditation and QS World University Rankings 2024 of the GGSIP University.

The members of the Court congratulated the Vice Chancellor and his team on this great achievement.

The Hon'ble Chancellor appreciated the same and advised to maintain the pace of the improvement and move forward towards achieving excellence.

Agenda Item No. 13.04: To consider Presentation by the Vice-Chancellor regarding Establishment and Growth of the University.

- 1. The Vice-Chancellor made a detailed presentation regarding the establishment and growth of the University. The Highlights of the presentation are as under:
 - a) The Vice Chancellor apprised the Court that the Guru Gobind Singh Indraprastha University started from the Kashmere Gate campus in the year 1998 and shifted to Main Dwarka Campus in the year 2010-11. Further, the University started East Campus at Surajmal Vihar, Delhi in the year 2021-22 in an area of 18.75 acres.

b) The Vice-Chancellor informed the Court about the accreditation/ ranking status of the University, the National Assessment and Accreditation Council (NAAC) accredited A++ Grade to the University during its Third Cycle of accreditation and has awarded 3.56 on a 4 point scale for a period of seven years w.e.f. 14.02.2023.

He further informed that the University has improved its NIRF ranking at 74 in the University category. Further, the University has been placed amongst the Top 1500 Institutions in the QS World University Ranking 2024. Only 45 Indian Universities including GGSIPU are listed in the QS World University Rankings 2024.

- The Vice Chancellor informed that Centre for Distance and Online Education has been established in April 2023 by following the UGC guidelines. The UGC provides that the Higher Educational Institutions (HEIs) having NAAC score 3.26 and above or having rank in Top 100 in University category of NIRF, at least twice in three preceding cycles, shall be permitted to start full-fledged Online programmes without prior approval of the UGC.
- d) The Vice-Chancellor informed the Court that total 18 schools of studies (including 02 Off Campus School) are operational from its Dwarka and East Campus. The University has established six new school(s) of studies in the last three years.

In addition, three centres namely the Centre of Excellence for Disaster Management, Centre of Excellence for Pharmaceutical Sciences and Centre for Human Values and Ethics with "In situ Centre for Sustainable Nitrogen and Nutrient Management" in the University School of Biotechnology (USBT) and "In-situ Centre for Sustainability and Climate Change' in the University School of Environment Management (USEM) are functioning from the Dwarka campus,

- e) The Vice Chancellor informed that the Campus is well structured with inclusiveness for Divyangjans with Divyangjan friendly washrooms, parking facilities, tactile path, ramps/ lifts, scribe assistance, daisy player ctc. Also, the Day Care Centre, All Women Police Post, Girls Common Room and gender Champions Club exists for gender-just inclusive campus.
- f) Further, it was informed that a total of 191 numbers (Including 50 in campus) of programmes are running at the University. At present, 113 institutes (88 Self Financing and 25 Government) are affiliated with the University situated in Delhi and NCR with 83671 plus students enrolled.
- g) The Vice-Chancellor informed that the University offers Undergraduate/ Postgraduate/ PG Diploma/ Doctoral programmes, Dual Degree Programmes, Integrated programmes, and UG, PG Super Speciality, Doctoral, Diploma & Post Graduate Diploma under Medical & Para Medical & Allied Health Sciences. The details of new academic programmes introduced in the Academic Year 2022-23 are as under:

- h) The Vice Chancellor apprised the Court that the University is admitting the students in the University School of Studies (USS) and Affiliated Colleges by following 3 modes of merit through i) the National Level Test ii) Common Entrance Test (CET) and iii) Some Post-Graduate Programme (Weekend) in USS through merit basis of qualifying examination marks.

The order of preference of admissions for UG/ PG/ M.Phil/Ph.D./Diploma Programmes is National Level Tests (wherever applicable); thereafter, Common Entrance Test (CET) conducted by University; thereafter CUET (conducted by NTA) (wherever applicable).

- i) The Vice Chancellor shared the data of Undergraduate/ Post Graduate/ M.Phil./ Ph.D. degrees awarded during the last five years by the University which presented a significant increase i.e. 27,527 in the year 2022 as compared to 23187 in 2018.
- j) The members were also apprised about the publications by the University faculties in high ranked journals such as SCOPUS and Web of Science with number of publications as 5148 and 2140 respectively. It was also informed that the H-index of the University has substantially increased to 74 in 2023 from 63 in 2022
- k) The Vice Chancellor informed that a total 18.42 Crores extramural grants has been generated by the University faculty through projects funded by DBT, DST, ICMR, CSIR, SERB, UGC, DRDO & ICSSR.
- The Vice Chancellor apprised the Court about the placement activities in the University. It was informed that a total number of 728 students of University School of Studies were placed with an average salary of Rs. 12.00 LPA. Similarly, 12000+ students of affiliated institutions were placed with an average salary of Rs. 7.50 LPA (Approx.).
- m) The Court was informed that the University is providing an innovation and Incubation Ecosystem to the students through the 'Atal Incubation Centre' supported by Niti Aayog. The 1st year Grant of Rs. 2.59 Crore out of total Grant-in-Aid of Rs. 10 crores has been received. Further, IPU-Innovation and Incubation Foundation (IPU-IIF) is registered as a Section 8 Company and has supported 18 Start ups and 26 pre-incubation projects so far. In addition, a grant of Rs. 55 Lakhs has been received from AICTE for AICTE Idea Lab where the students are trained for idea actualization and prototype development and the same is providing a pathway for the creation of start-ups by the students.

n) The Vice Chancellor apprised the Court that the University has signed 95 MOUs (75 National and 20 International). International MOUs are active with France, Bosnia, Italy, Austria, Taiwan, Hungary, Korea, Mexico, Kenya, UK, Poland, Japan, USA, Australia and Russia. MoUs with the national institutions/ industries includes IBM, ICSI, AUD, NIOS, SMC Global, BIPS Systems Ltd. Cisco Networking Academy, NSE, NIDM, NDRF, IIRS, IETE, Computer Society of India, DJB, DFS, STPI, Centre for Rehabilitation and Advancement of Disabled, Delhi State Aids Control Society, The Handmade Paper and Board Industries, Google Asia Pacific, Network Bulls, PHDCCI, EdCil, Centre for Quality and Food Safety, Association of Healthcare Providers, etc.

The Court was also informed that the University has recently signed an important MOU with NIOS for fostering academic and research partnership between the Institutions during the Akhil Bhartiya Shiksha Samagam which was inaugurated by the Hon'ble Prime Minister, Shri Narendra Modi on 29.07.2023.

- The Vice-Chancellor apprised the Court about the implementation of NEP 0) 2020 by way of expanding the multidisciplinary nature of the University through new schools such as the School of Liberal Arts. School of Film Making, School of Fire and Industrial Safety, School of AYUSH, creation of 24211 accounts and uploading of 82483 degree in the Academic Bank of Credits (ABC), National Academic Depository Portal, implementation of multiple entry and exit system programmes such as BA, BBA, B.Com. B.Sc., MBA, etc., offering Dual Degree with multiple entry and exit in upcoming BA-Maand B.Sc.-M.Sc., B.Tech.-M.tech programmes, value added course on Indian Knowledge Traditions and Philosophy by the Centre of Human Values and Ethics, Choice Based Credit System (CBCS) implementation with increased choice of open and discipline-specific electives, 'SCHEME FOR TRANSLATIONAL AND INTERDISCIPLINARY RESEARCH' (STEER) Outcome Based Education, embedding of Internship/ Apprenticeship in Engineering and Technology and Law Programmes, adoption of Blended Mode of teaching, adoption of MOOCs & Swayam courses, embedding Indian Knowledge System such as Yoga, Ayurveda, Ancient Management Philosophy and India Ethos, existence of Online Alumni Portal for Alumni engagement, Creation of Research and Development Cell & Internalization of the University.
- p) The Vice-Chancellor briefly apprised the Court about the plans/ activities for the Silver Jubilee Celebrations of the University which includes Half Marathon, Adoption of 25 villages of Delhi and outreach programmes (Legal Aid, Financial Literacy, Cyber Hygiene, Sports, Educational Awareness, Environmental Awareness, Health Camp Awareness), Public Lectures (Bimonthly), Health Mela, Silver Jubilee Alumni Meet, Creating a museum of 25 years journey, Release of commemorative stamp, Release of commemorative currency coin, Felicitation of distinguished members, Compendium of 25 Years of the University and Documentation of University Journey in Visual & Print Form.
- q) The Vice-Chancellor informed that the University is conducting various activities on G-20 theme, a brief of which is as under:
 - a. **Infrastructural Activities:** a total 156 Initiatives like Display of Banners, G20 Flags, Cutouts, Facade Lightings etc.,

- b. **Public Engagement Activities:** Half Marathon, Blood Donation, Yoga day celebration
- c. **Academic Activities:** A total of 228 Activities like Lectures, Conferences, Workshops, Seminars etc.
- d. Inclusive Activities: Wheel Chair Cricket and race
- e. **International Activities:** A Total of 48 Activities like visits of Delegations, Seminars, Conferences and Workshops etc.
- f. Other Activities: Cultural Heritage, Cultural Fest Anugoonj, Legal Aid, Green Awareness
- r) The Vice Chancellor apprised the Court about the Annual Accounts for the Financial Year 2019-20 and 2020-21. The total income and the expenditure, application of funds, sources of University income, bifurcation of expenditure was also shared for the F.Y. 2019-20 and 2020-21.
- s) The Vice-Chancellor also apprised the Court about the CAG Audit Report of the University for the Financial Year 2019-20 and 2020-21 which has no Audit Para.
- 2. The Hon'ble Chancellor appreciated the progress, performance & efforts of the University made so far and exhorted to keep doing the good work. The University Court deliberated on the presentation made by the Vice Chancellor and gave their comments and suggestions which are as under:
 - a) The Hon'ble Chancellor emphasized on the issues related to environment and in view of the Green Credit boom and having the School of Environment Management in the University with a specialized *In-Situ* Centre of Sustainability and Climate Change, he suggested that the University should make efforts to convert the existing planted trees into Green Credit for benefit of the public of NCT of Delhi.
 - b) Sh. D.P. Singh further mentioned that the University should collaborate with industries and help them to earn carbon credit.

In addition, Ms. Anu Bararia mentioned that some short term certificate/diploma courses for educating people on Climate/ environmental issues which requires immediate concern may be explored.

The Hon'ble Chancellor asserted the suggestions of Sh. D.P. Singh and mentioned that the issue is very important and as the University is having a green campus, may take advantage of taking Carbon Credit.

- c) The Hon'ble Chancellor suggested that the activities related to awareness on cleanliness (Swachh Bharat Abhiyan) should also be included in the activities conducted in the villages adopted by the University and its affiliated colleges/ institutions under its Outreach Programme. Hon'ble Chancellor further observed that there is visible transformation in vision for cleanliness with the initiatives of Hon'ble Prime Minister. Hon'ble Chancellor advised that efforts towards cleanliness should be continued.
- d) The Hon'ble Chancellor suggested that the University should explore possibilities of starting Post Doctoral Programmes so that migration of the students for pursuing Post Doctoral courses to other universities in abroad could be minimized.

e) The Vice Chancellor informed that a proposal for setting up of the North Campus of GGSIP University in the upcoming educational hub in Narela and providing flats in the nearby areas, has been submitted to the Vice Chairman DDA.

The Hon'ble Chancellor suggested to make an assessment of the actual requirement for the flats and forward a detailed proposal for consideration.

- f) Sh. D.P. Singh appreciated that the University is organising Health Mela during its Silver Jubilee Celebrations for serving the community. He further mentioned that the University should make efforts to provide support to the people affected by flood/ other natural disaster as the University has a specialized Centre of Excellence in Disaster Management.
- g) Sh. D.P. Singh mentioned that sports are an important element of a student's growth and overall development. He further mentioned that the University should allocate seats for the sports persons in admissions. He suggested that the University may consider the specialized agencies of sports for developing/ maintaining the sports facility in the University.

Sh. Sumer Sarin added that sports is an integral part of human development hence, the University should stress upon providing sports facilities to the students.

The Vice Chancellor informed that the University is conducting Annual Sports Meets and the students are participating in the Inter-University Competitions outside the University.

The Hon'ble Chancellor mentioned that sports are as important as academics and suggested that the University should develop sports infrastructure in the University for Competitive Capacities. He advised that the University should provide support to the students to attain skills in sports to achieve fame. It was also advised to examine the issue raised in the meeting and explore granting admission in the University on sports quota basis also.

h) Sh. D.P. Singh mentioned that there is an acute shortage of trained nurses in abroad and suggested that foreign languages should be included in the Course Curriculum of the Nursing Programme.

The Vice Chancellor informed that the Nursing programme is running in the affiliated Institutes of the University and the Course Curriculum is designed by the Indian Nursing Council.

Prof. Vivek Sachdeva informed that the University has started Diploma in Foreign Languages on weekend mode. The students pursuing Nursing progeramme may take advantage of the same and join the course in addition to the regular studies for value addition and enhancing their skills to serve in abroad.

i) Sh. D.P. Dingh emphasized on need of imparting value and character building in the students. He mentioned that the students should be encouraged for maintaining cleanliness.

It was informed that the University is already organizing One-Week Orientation Programme (SIP) on Values and Ethics at the time of admission of the students in the University/ affiliated colleges and the same may be continued for reinforcement on regular basis.

j) Sh. Sumer Sarin suggested that the University should offer Integrated Programmes across the streams so that integration of different disciplines could be made.

It was informed that he University is already running integrated programmes such as BALLB/ BBALLB and further that a proposal for starting BA-B.Ed. Programme has been sent to National Council for Teacher Education (NCTE).

k) Sh. Tanweer Alam suggested that the nomenclature of the programme M.Sc. (Packaging Technology) running in Indian Institute of Packaging, may be considered for conversion to MS in Packaging Technology as compared with the foreign Universities. The Vice Chancellor informed that as per the UGC Guidelines, there is no provision for MS Degree in India.

The Court members were in opinion that the matter for consideration of MS Degree may be deliberated and decided in the Academic Council of the University, as deemed fit.

I) Hon'ble Chancellor advised that efforts should be made to increase number of foreign students in the University. It was also advised to raise the standards of the University so that foreign Institutions should look towards us.

Agenda Item No. 13.11:

The Vice Chancellor apprised the members that the University is managing its affairs through self–finance mode and is not getting Grant-In-Aid from the Government for recurring/ non recurring expenditure of the University.

The construction of Phase –1 of Dwarka Campus was completed in 2010 for which the capital grant for construction and development was received from the Government of NCT of Delhi. Since then, the research/ academic activiites have been enhanced manifolds and due to adoption of NEP-2020, the University has introduced new programmes which requires additional infrastructure.

Accordingly, a proposal for Phase-II Construction of Dwarka Campus was prepared and an estimate of work amounting to Rs. 973.98 Crores for Phase-II Construction of GGSIP University, Dwarka Campus has been sent by Public Works Department to Directorate of Higher Education for accord of A/A and E/S on 21.03.2023.

He mentioned that the Phase-II Construction shall help to increase number of seats and would benefit additional 6950 students of the NCT of Delhi and requested to allocate the funds for Phase-II Construction of Dwarka Campus. The Hon'ble Chancellor advised Secretary (Higher Education) to look into the matter

The Vice-Chancellor thanked the Chair and all other members of the Court for their valuable suggestions which will be attributable to the growth of the University.
