At the outset of the meeting, Hon'ble Vice Chancellor extended warm welcome to all present Members of Finance Committee. He lauded the contribution of the members for sparing their valuable time in attending meetings and guiding the university in formulating its financial policies which is very well evident with the formulation and implementation of various financial norms and policies in last three years.

The Controller of Finance had informed that if might be last meeting for nominated members of the present Committee whose term was going to be completed soon therefore before taking up agenda items with the permission of chair, he summed up important recommendations of the Finance Committee during the last 3 years:

During the tenure of present committee in the less than three years, a total of 10 number of meeting of the Finance Committee were held. During this period, income of the University had increased from Rs. 99.00 cr. in the year 2010-11 to Rs. 138.00 cr. in the year 2013-14. The expenditure of the University had

also risen from 57.00 cr. in 2010-11 to around Rs.100.00 cr. in the year 2013-14.

- ii) The corpus of University had increased from Rs. 153.00 crores in the year 2010-11 to Rs. 181.00 crores in the year 2012-13.
- iii) The following important decisions had been taken in the Finance Committee meetings during the period:

(a) Medical Attendance & Treatment Regulations 2000 (Revised)

(b) Approved rates to Academic, Administrative, Examination and other activities in the University

(c) Perks & Privileges to University functionaries

- (d) Approved Forms for claiming Advances / Honorarium / Perks & Privileges / Personal Claims
- (e) Development Grant for Purchasing of Miscellaneous Items to
- (f) Development Grant for Purchasing of Laptop / Tablet to Faculty

- (g) Participation of Faculty Members for attending National & International Conference / Seminars
- (iv) Apart from it, the Ordinance related to Pension-cum-General Provident Fund Scheme and Group Insurance Scheme to the employees of GGS IP University had been formulated and sent to the Govt. of NCT of Delhi for issuance of notification.
- (v) The Annual Accounts for the year 2010-11, 2011-12 and 2012-13 along with audit report for the year 2009-10, 2010-11 and 2011-12 had been approved by the Finance Committee. The University accounts had been updated and audit report for the year 2012-13 is awaited from C&AC office.

Thereafter with the permission of the Chair, the agenda items were taken up.
