Agenda Item No. FC-48.03:

To consider and approve the revision of Hostel Fees of GGS IP University, Dwarka.

The Finance Committee deliberated upon the revision of hostel fee structure including hostel mess charges. It was informed to the Members that from the income generated from hostel charges all expenses related to maintenance of hostel could not be met and the University has been contributing remaining resources to maintain the University hostels. Wages of security guards, sanitation workers, office assistants and other supporting staff have increased in last 2 years apart from increase in the cost of other maintenance services. The Member agreed with the proposal for increase in the Hostel Fees and other proposed Mess fees however, resolved that increase in Mess Maintenance Charges (annual) should be Rs. 500/- to Rs. 1,000/- in the current year which may further be increased to Rs. 1,500/- (annual) in subsequent years.

The meeting ended with a vote of thank to the Chair.
