**Addendum to the Part A, Admission Brochure 2017-18 vis-à-vis Notification of admission in Post Graduate Ayurveda Courses (MD/MS Ayurveda)**

This has reference to the letter from Ministry of Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homoeopathy (AYUSH), Govt of India; No. F.No. R-11011/04/2016-EP(IM-1) dated 15/2/17.


The aforesaid letter states that All India Institute of Ayurveda will conduct an all India level common entrance test namely *AYUSH National Post Graduate Entrance Test (AYUSH NPGET)* for admission in all AYUSH PG courses from the academic session 2017-18. To ensure compliance of this decision of the Ministry, all admissions in AYUSH Post Graduate courses shall be conducted through AYUSH NPGET only.

The University, in its Admission Brochure 2017-18 Part A, had notified that there shall be a Common Entrance Test (CET) for admission in Post Graduate Ayurveda Courses (MD/MS Ayurveda) on 21<sup>st</sup> May 2017; but in the wake of afore mentioned direction from the Ministry of AYUSH, it is hereby notified that GGSIPU will not conduct Common Entrance Test (CET) [Programme Code 196] for Post Graduate Ayurveda Courses for admissions in 2017-18.

The admissions in Post Graduate Ayurveda Courses (MD/MS Ayurveda) shall now be based on the *AYUSH NPGET* merit as stated above i.e. on the *AYUSH National Post Graduate Entrance Test (AYUSH NPGET)*. However the candidates desirous of seeking admissions in PG Ayurveda Courses are to register themselves on the link 'Admissions 2017' on the University website.

The candidates, which have already filled up the CET form for PGAC CET Code 196, shall be treated as 'Registered Candidates'. The University shall open the portal for these "Registered Candidates" for uploading the AYUSH NPGET score in due course of time.
