Schedule for 'Registration of Counselling' and physical submission of NEET UG 2017 details for Admission in BAMS (Bachelor of Ayurveda, Medicine & Surgery, CET Code Code 153 : Academic Session 2017-18

1. Attached herewith is the list of candidates who had submitted online application for admission in BAMS, CET Code 153. THE CANDIDATES WHO HAVE NOT SUBMITTED ONLINE APPLICATION FORM ON THE UNIVERSITY'S PORTAL FOR ADMISSION IN BAMS ARE NOT ELIGIBLE FOR COUNSELLING PROCESS.
2. This is a Schedule for 'Registration of Counselling' and physical submission of NEET UG 2017 details in the University, in person, on the notified date and time.
3. IT IS MANDATORY FOR ALL THE CANDIDATES TO GET THEMSELVES REGISTERED ON THE NOTIFIED DATES AND TIME FOR PARTICIPATING IN THE COUNSELLING.
4. IT IS REITERATED THAT IN NO CASE, A CANDIDATE WILL BE ALLOWED TO PARTICIPATE IN THE COUNSELLING UNLESS HE/SHE HAS REGISTERED FOR PARTICIPATION IN THE COUNSELLING.
5. All the stake holders are requested to see the list annexed herewith. In case of any representation / discrepancy in the notified list, the candidates shall point-out the same preferably on their day of 'Registration' as notified below; but not beyond the notified schedule.

In case of any correction to be carried out, (as pointed out by the candidate, as mentioned in the above para) in Date of Birth, spelling mistake in the name or in the name of parents or in the choice of category / region claimed for the purpose of availing reservation in the submitted online form, application has to be submitted in the physical form alongwith the fee of Rs.500/- (to be deposited through Challan in the Indian Bank, GGSIPU Dwarka Campus Branch) in the Admissions Branch, GGSIPU Dwarka, Sector 16-C, Dwarka, New Delhi-110078 from 10.00 AM on 12.10.2017 (upto 4.00 PM) to 13.10.2017 (upto 4.00 PM).

All the candidates who find any discrepancy in the list, which require submission of fee of Rs.500/-, as explained above, and if; they have been called on 14.10.17, are requested to visit for Registration of Counselling and submission of NEET UG 2017 details BEFORE 14.10.17 (i.e. on 12.10.17 and 13.10.17 because there shall be a bank holiday on 14.10.17 being Second Saturday due to which they shall not be able to deposit the required fee of Rs.500/- as mentioned above.

6. Candidates are requested to please refer to the Admission Brochure 2017-18 for details please.

7. 85% seats shall be reserved for the candidates of Delhi Region i.e. who have studied 10+2 (11th and 12th) classes in the recognized School/College in Delhi and passed the qualifying examination from any School/College located in Delhi only; while 15% seats are reserved for Outside Delhi Candidates.

8. For the Defence Category and PWD/PH Category, 5% seats are reserved (horizontally) in every Region / Category. Admission Brochure 2017-18 may please be referred for the Defence Priorities (I TO VII) and the required Appendices, which shall be required at the time of seat allotment. For PWD/PH category the candidates shall submit the requisite certificate issued from the competent authority. Candidates claiming PWD / PH seats may please refer to the University's notification GGSIPU/Admissions/2017/21659 dated 03.07.17.

9. **Clarification of Scheduled Caste Category Certificate (with regard to Delhi SC candidates).** It is seen that some SC category certificates issued by competent authority of NCT of Delhi has a clause stating that this certificate is issued on the basis of certificate of parent issued by competent authority of a State / UT other than NCT of Delhi.

The benefit of reservation shall also be extended to all candidates who hold SC certificates issued from GNCTD provided such caste is enlisted in the list of Scheduled Caste as specified in Presidential Order 1951 as amended from time to time in respect of Delhi subject to fulfillment of other conditions specified therein. Please refer to the Annexure A attached to this notification.

Such candidates whose certificate has been issued by competent authority in GNCTD but their castes do not fall in Delhi, as specified in the Presidential Order 1951 (Annexure A above) shall not be considered for admission against seats reserved for 'Delhi Region Category'.

10. **Clarification on Other Backward Class Certificates.** Same as above, a certificate issued by a competent authority of Delhi on the basis of caste certificates of his/her parents from another State, will be accepted for claiming seat in OBC category if and only if the caste is in the list of notified OBC list by Govt of NCT of Delhi for claiming benefit of 'Delhi Region OBC'. THE NON-CREAMY LAYER CERTIFICATE SHOULD BE ISSUED AFTER 1ST APRIL 2017.
