**SCHEULE FOR FILLING UP VACANT SEATS IN PROGRAMME**  
**M.PHIL (CLINICAL PSYCHOLOGY) CET CODE 157 THROUGH**  
**DIRECT MODE BY PGIMER, DR RML HOSPITAL**

**ACADEMIC SESSION 2017-18**

The University conducted Offline Counselling for admissions in M.Phil (Clinical Psychology) in the Academic Session 2017-18. The University, due to non-receipt of any withdrawal from the admitted candidates; within the stipulated date, did not carry out the Second Counselling. Consequently, as per the provisions of Admission Brochure, the University notified that 'there shall be no Second Counselling for admission in M.Phil (Clinical Psychology). Thereafter, consequent upon three withdrawals (UR Category – 02 seats and ST Category – 01 seat) in the programme M.Phil (Clinical Psychology), the procedure for filling up those unfilled seats is given in the succeeding paras.

The dates, by which, activities for filling up of seats through Direct Admission is to be completed, is stated as below:-


<b>Date</b>	<b>Activity to be done</b>
<b>04.10.2017</b>	Constitution of Admission Committee at PGIMER Dr RML Hospital comprising of Director/Dean, two faculty from the institute. The institute shall request for the appointment of the University Observer.
<b>04.10.2017</b>	Uploading of Admission Notice on Institute's website
<b>05.10.2017 to 09.10.2017</b>	The eligible candidates shall apply in the Institute
<b>10.10.2017</b>	Merit List to be displayed by the College on their website and notice boards
<b>13.10.2017</b>	Counselling to be done at Institutes from the merit list for provisional allotment
<b>16.10.2017</b>	Files of admitted candidates to be submitted in GGSIP University for verification and admission

**IMPORTANT NOTE :**

- The candidates shall refer to the Schedule of First Counselling, No. GGSIPU/Counselling Schedule/CET-157/2017/21930 dated 10.7.17 for documents required at the time of counselling. Fee payable at the time of Counselling is Rs.20,000/- (balance, if any, payable at the college directly after admission) through Demand Draft in favour of 'Registrar, Guru Gobind Singh Indraprastha University', payable at New Delhi.**
- Admissions shall be strictly from among the merit of CET 2017 qualified candidates.**

3. The admissions shall be granted only to those candidates who are CET Qualified and had applied in the college as per the above notified schedule.

4. Seat vacated by an ST Category candidate shall be filled up by the ST Category candidate only. If ST category candidate is not available, the seat shall be offered to the SC Category candidate available in CET 2017 merit. If no SC Category seat claimant is available, then the seat shall be converted into 'General/UR' category and be filled up on the basis of CET 2017 merit.
