PURELY ON MERIT**

→ "NEET ALL INDIA RANK" shall be referred to as 'Rank' further in this schedule.

1. This is in continuation to University's Notifications Nos. GGSIPU/Admissions/2017/ 25982 dated 10.10.2017; 26162 dated 13.10.2017; 26366 dated 17.10.2017; Schedule of First Counselling No. 26431 dated 23.10.2017 and Schedule of Second Counselling No. 26686 dated 30.10.2017

It is mentioned that Ministry of AYUSH vide its notification dated 06.11.2017 has extended the cut-off date for admission in Ayurveda, Unani, Siddha and Homoeopathy courses to 22.11.2017.

For the purpose of withdrawal and refund of fee, all are requested to please go through the "Supplementary Fee Refund Policy for Academic Session 2017-18 for Withdrawals / Cancellation of Admissions during the Academic Session 2017-18", notified vide, Notification No. GGSIPU/Admissions/2017/26740 dated 31.10.2017 pertaining to medical and para medical courses.

2. The candidates who appeared in NEET UG 2017, have submitted online application for admission in GGSIPU and had registered in GGSIPU (for admission in BHMS programme) on the stipulated dates, shall report in person for Verification of Documents and Allotment of Seats, at the venue of counselling, on the date and time mentioned in the succeeding paras, as per their Category and Rank.

3. Merit of the candidates shall be ascertained after physical verification of documents at the time of counselling.

4. All the candidates are requested to visit the University website www.ipu.ac.in regularly for updates please.
5. For Eligibility, Age Limit etc, the candidates are requested to please refer to the Part A of Admission Brochure 2017-18 and for requisite Annexure / Appendices they shall refer to the Part B of Admission Brochure 2017-18 available on University website. And, for 'Fee to be paid at the time of Counselling' and 'List of documents required at the time of counselling', etc. please refer to the Schedule of First Counselling, No. 26430 dated 23.10.2017.
6. Any reserved category seat(s) shall be first offered to the candidates of that particular category only; and shall be converted, if a candidate in that particular category is not available, during the Extended Second Counselling as per the notified rules.
7. Final Region-wise / Category-wise Seat Matrix shall be displayed at the time of counselling. However, the vacant seats, arisen due to withdrawals, upto 14.11.2017 are mentioned below for ready reference:

8. Counselling for the seats reserved for any Region / Category shall be stopped as and when the seats in / of such Category / Region are filled up. All the candidates have been called to ensure that all the seats are filled up.
9. Fee to be paid at the time of Counselling. At the time of counselling / admission in the University, a candidate will mandatorily bring a demand draft of Rs.15,590/- (fifteen thousand five hundred ninety only). This amount includes non-refundable Counselling Participation Fee of Rs.1000/-. The demand draft shall be in the name of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. No candidate shall be granted admission without the demand draft of requisite fee, as mentioned above.
- Balance fee, if any, shall be paid by the admitted candidates, directly in the allotted college.
10. All the candidates admitted in the Extended Second Counselling, shall report in the allotted college immediately after admission.
11. All the refund applications shall be processed in accordance with the Supplementary Refund Policy 2017-18, notified by the University as mentioned above in para 1.
