IMPORTANT NOTIFICATION REGARDING MBBS ADMISSION

Counselling / Admission on the vacancy(ies) arisen on 30.8.2017 in
'ArmyDef' Seats in ACMS : MBBS programme

It is for urgent information of all the stake holders that the following vacancy has occurred consequent to the receipt of 'Withdrawal' from a candidate. The details are given below :-

Category of Vacant Seat	-	ARMYDEF
Number of Seat	-	01 (one)
Medical College	-	Army College of Medical Sciences

It is elaborated here that the admissions on the above category seats are done on 'All India Basis' i.e. without any regional distribution (Delhi/All India) purely on NEET ALL INDIA MERIT to the eligible candidates in Defence Priority (1 to 7).

The MCI Regulation, states the 'last date upto which students can be admitted against vacancies arising due to any reason' is 31st August 2017.

It is stated that the Admission Counselling for **filling up this vacant seat shall be held at 3.00 PM on 31.8.2017 in D Block Seminar Hall, Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi. Only the candidate, who has not taken admission in MBBS during the Academic Session 2017-18 is eligible for counselling.**

The candidates who did not register are not eligible for counselling. **Candidates from NEET ALL INDIA RANK 01 ONWARDS are eligible to attend the counselling.** All the candidates claiming seats in Defence Priority (I to VII) shall visit the University on the notified date and time. The University has already, on its website notified the list of P-1 to P-V who had got themselves verified within the notified date and time.

If this seat remains unfilled, after exhausting the eligible candidates from Defence Category, the same shall be reverted to its parent category i.e. 'Army'.

Counselling shall stop as the seat is filled up.
