1. This is in continuation to University's notification No. GGSIPU/Admissions/2017/25819 dated 03.10.17, titled, "Schedule for 'Preparation of Merit List' for Admission in Post Graduate Ayurveda Courses (PGAC) i.e. MD/MS Ayurveda Courses, CET Code Code 196 : Academic Session 2017-18".
2. Consequent upon the Registration for Counselling and verification of documents, the University shall display the merit list on its website, on 14.10.17.
3. It may please be noted that the candidates who would not register for counselling on the University's notified dates, are not eligible to participate in the counseling.
4. Two separate merit lists shall be notified i.e. 'GGSIPIU Quota' and 'All India Quota'. Tentative Seat Distribution is given below. The final seat matrix shall be displayed at the time of counselling.
