### NOTICE FOR THE ADMITTED STUDENTS THROUGH ONLINE/SPOT COUNSELLING IN VARIOUS PROGRAMMES ACADEMIC SESSION 2018-19.

This is in continuation to University Notification No. 4620 dated 06.08.2018 regarding 'Schedule for filling up remaining vacancies: Supplementary Counselling / Admissions, after Spot/Open House Counselling Stage-I followed by Stage-II. The University making efforts to fill up the vacant seats, is carrying out admissions on vacant seats in CET/Programme by conduct of Supplementary Counselling Stage-I in various programmes on 12.08.2018 and on 13.08.2018, in consonance with the procedure as notified vide Notification No. 4620 dated 06.08.2018.

Reference may please be taken of earlier University notification No 4238 dated 20.07.2018, by which all those candidates who were allocated seats for CET/Programme through online counselling were directed to report to the respective School/College/Institute within stipulated dates as notified in the said notification. All Schools/College/Institutes submitted the status of reported and admitted students and the remaining vacancies (if any) in the Programmes in respective School/College/Institute was further taken and offered to the candidates in the Spot Round of Counselling. Also, vide Notification No. 4626 dated 06.08.2018, the students who were allotted a seat (transferred / fresh allotment) in SPOT Round of Counselling of Programmes were requested to report to their allotted respective / colleges at the earliest as the academic session 2018-19 already commenced.

Further, Supplementary Counselling for filling up remaining vacancies is being conducted vide Notification No. 4620 dated 06.08.2018 and if still due to non-fulfilment of all vacant seats through Stage-I. Also meanwhile the vacancies (if any) arises due to withdrawals between 12.08.2018 and 13.08.2018, the vacancies shall be filled up through Supplementary Counselling Stage II to be conducted at the respective Schools/colleges/Institutes.

**Therefore it is hereby informed that If any Admitted Student who has taken admission** whether through online Counselling and/or transferred / freshly admitted in Spot counselling, **does not desire / wish to pursue course/Programme he/she has been admitted to,** and if so desires to withdraw his/her admission , may submit the duly completed withdrawal application form in the Admission Branch GGSIP University during working hours by 13.08.2018(upto 5.00 PM) ; so that the seat in the Course/Programme in the respective College/Institute vacated by them on withdrawal within notified date and time can be taken as vacancy to the Stage II round of Supplementary Counselling. Such Vacant seats thus in general interest can be offered to other prospective eligible candidates for Supplementary Counselling Stage II.


Thus, in general interest of all stakeholders, such admitted students desirous of submitting withdrawal application, may submit it upto 5 PM of 13.08.2018.
