**1. Who all are eligible for Spot Round:-**

- (i) A candidate who was allotted a seat in online round of online counseling, paid the part academic fee and reported;
- (ii) A candidate who was allotted a seat in online round of online counseling, paid the part academic fee but not reported in the allotted institute;
- (iii) A candidate who was not allotted any seat in any round of online counseling
- (iv) A candidate who was allotted a seat in online counseling but not paid the part academic fee
- (v) All CET qualified candidates who did not register for online counseling
- (vi) All CET qualified candidates who registered but not paid the participation fee
- (vii) All CET qualified candidates who registered, paid the participation fee and did not fill the choices;
- (viii) Any candidate who was admitted in any round and subsequently withdrawn as per procedure;
- (ix) Who were allotted a seat, paid the part academic fee and froze the allotted seat
- (x) All 'not admitted' candidates

**Note : "Admitted" candidate means any candidate who was offered a seat in any round of online counseling, paid the Part Academic Fee of Rs.40,000/-, paid the balance academic fee in the allotted college and shown 'reported' by the college.**

**(2) 'Admitted Candidates' if do not appear on the specified and scheduled date and time, as mentioned above, in the Spot Round of Counselling, as per his/her rank, shall not be entitled to participate the Spot Round of Counselling in the subsequent slot/days and shall not claim for his/her Merit Rank as he/she did not report at the time of his/her Merit Slot in spot counseling.**

**(3) Fees**

**All Candidates ('Admitted' and 'Not Admitted' are required to be ready with the Bank Demand Draft of requisite fee, well in advance as 28.07.2018 and 29.07.2018 being Bank Holidays. No provision is of Payment of fees by Cash /Debit Card/Credit Card/ Online Payment etc.**

**A. Documents required at time of Spot Round Counselling:**

- a) A copy of "Provisional Admission Slip" from the candidates' login, in case of admitted candidates and proof of submission of Part Academic Fee of Rs. 40000/-.
- b) CET Admit Card of CET-2018 (Photocopy in case of admitted candidates/Original in case of fresh candidates). If original Admit Card/character certificate/medical certificate is submitted at the Designated Centres at the time of Verification of Reserved Category certificates the candidate shall produce the duly attested photocopy of the same.



- c) Copy of Admission Verification Form (duly filled by candidate as per Appendix 4(A) given in Part B in case of new admission in case of fresh admission)
- d) Preference Sheet duly filled by candidate as per Appendix 7 given in Part B in both admitted candidates and fresh admission.
- e) Proof of date of birth (10<sup>TH</sup> Class passing certificate or marksheet) (Original and Photocopy).
- f) **Marksheets/Certificates of qualifying examination:** The candidate will be required to bring the Original Certificates/Marksheets of all the year wise or semester wise in original alongwith self attested photocopies of Certificates/Mark sheets of qualifying examination.
- g) **For result awaited cases:** Undertaking/Self declaration by the candidate for provisional admission only in case the result awaited (duly filled by candidate as per Appendix 5 given in Part B)
- h) **For Distance/ Open Learning Cases:** In case of students who have passed the qualifying examination through distance/ open education system of any recognized University/ board/ institution, the necessary documentary evidence related to location of his/her study centre i.e. study centre proof, certificate from the University imparting open/distance education certifying the location of the study centre to be submitted.
- i) **Medical Certificate:** All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per Appendix 6 given in Part-B in Admission Brochure 2018-19. (Photocopy in case of admitted candidates/Original in case of fresh candidates)
- j) **Character Certificate** from Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer (not more than 6 months old) (Photocopy in case of admitted candidates/Original in case of fresh candidates)
- k) In case, the Degree/ Certificate has been obtained from University/ Board of any other country then an equivalence certificate must be obtained from Association of Indian Universities (AIU) New Delhi prior to attending the counselling.
- l) In case, any of the mentioned documents is/are in any language other than Hindi/ English, then authentic translation in English/ Hindi shall have to be produced duly verified by the Institution or Gazatted Officer by the candidate at the time of counselling. Failure on the part of the candidate to produce the requisite document may result in refusal of admission by the Admission Officer, for which the candidate will be responsible.
- m) Candidates belonging to Scheduled Castes/Scheduled Tribes/Widows or Wards of Defence Personnel/ Persons With Disability will be allowed 5% relaxation of marks in the minimum eligibility requirement, irrespective of the fact whether there exists any reservation for any category of such candidates or not.



*"Relaxation of any kind, as mentioned above and elsewhere in the Admission Brochure, will be granted to only those candidates, who are able to produce necessary relevant supporting documents as per the Admission Brochure before the Admission Officer present at the Venue of the Document Verification / Counselling / Admission. Therefore, for seeking these relaxation/s, necessary documents must be obtained in advance by all candidates from the Competent Authority as prescribed".*

- n) Undertaking by the student with respect to anti-ragging and undertaking by parent/guardian with respect of anti-ragging as per Appendix-13 and 14 of (Part B) of Admission Brochure for Academic Session 2018-19 available on University Website.
- o) Undertaking in respect of interim fees to be filled in by candidates admitted in Academic Session 2018-19 available on University Website.
- p) *It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfil all the conditions prescribed for admission. Before filling-up, the verification slip at the time of verification of documents/counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2018-19. If it is found at any stage during the entire period of the programme that the candidate does not fulfil the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.*

**C. Eligibility Conditions:**

Pass in 12th Class of 10+2 of CBSE or equivalent with a minimum of 50% marks in aggregate\* and must also have passed English (core or elective or functional) as a subject.

**For Eligibility Conditions & Admission Criteria, Chapter 2 of Part A of Admission Brochure 2018-19 may be referred.**

**D. Spot Counselling Procedure as per Chapter 11 of Part A of Admission Brochure 2018-19 may be referred.**

1. This round shall be held after completion of the admission process, only for the purpose of filling up vacancies, if any.
2. After completion of all rounds of online counselling 'Spot Counselling' shall be done offline. All eligible candidates desirous of participating in the "Spot Counselling" shall have to pay a counselling (separate) participation fee. The participation fees in the "Spot Counselling" shall be INR 2000/= (non-refundable / transferable).
3. The "Spot Counselling" shall be done for vacancies remaining after reporting of allocated candidates to Schools of Studies / Colleges / institutions allotted (see Section 11.10) and arising during the process of "Spot Counselling" as enumerated below. Since, all conversions of categories / region-wise divisions are completed in the last round of online counselling (Section 11.8), the spot counselling shall consider all seats to be filled as unreserved.
4. The vacant seats left after reporting /admission of candidates to institutions only shall be considered for filling in the spot counselling.
5. Any CET qualified candidates who have not taken admission in the rounds of Online counselling will be eligible to participate in the spot counselling, against the available vacant seat (if any).
6. The candidates who are allotted seat in rounds of online counselling and have paid the part Academic Fee of Rs 40,000/- to confirm admission in any institute/ college and have also reported to the concerned University School of Study / college / institutions will be treated as "admitted" at the time of Spot Counselling. Such candidates, if they desire to participate in the "Spot Counselling" shall be required to pay a transfer fees of INR 5000/-, these candidates shall be considered as per their rank only, if they do not appear at the time of counselling for their rank, they shall not be allowed to participate, moreover, the seats thus vacated by these candidates shall be offered to candidates participating in "Spot Counselling" with lower rank as compared to the candidates thus transferred. For such "transferred" candidates, the part academic fees paid by the candidate of INR 40000/- shall be adjusted during counselling. If a change of institution / college occurs of such candidates, then the institution / college from which the candidate is being transferred shall refund the balance fees paid (if any), that is the component of the fees paid by the candidate at the institution directly to the candidates on application by the candidate, and the candidate shall have to pay the balance fees (if any) of



the institution to which the candidate is transferred as per schedule to be notified by the candidates.

7. Any candidate, who was admitted in any round and subsequently withdrawn as per procedure, will be eligible to participate in the Spot Counselling.
8. All "Not Admitted" candidates will be eligible to participate in the Spot Counselling.
9. Vacancies will be displayed one day before the commencement of spot Counselling.


