Schedule of 2nd Round of Counselling

Schedule of Second Counselling for admission in Post Graduate Medical Courses (i.e. MD/MS/Diploma) in Guru Gobind Singh Indraprastha University for the Academic Session 2018-19

References :-

1. Order of Hon'ble Supreme Court of India dated 03.05.2018, in the Writ Petition (C) No. 357 of 2018, titled "Rachit Sinha & Ors. Vs Union of India & Ors".
2. In accordance with the Ministry of Health & Family Welfare Govt of India notification no. 11025/05/2017-MEP dated 27.04.2018, National Board of Examinations New Delhi has issued a Public Notice regarding "Revised Cut-Off scores for NEET-PG 2018". As stated in the above Public Notice, 'Revised Eligibility Criteria for NEET-PG 2018 as per directions of MoHFW' are as below :-

General	-	35 th percentile
SC/ST/OBC	-	25 th percentile
PWD	-	30 th percentile
3. Gazette Notification dated 05.04.2018 of Medical Council of India.
4. University's Notification No. GGSIPU/Admissions/2018/2521 dated 20.04.2018 regarding Schedule of 2nd Round of Counselling for admission in PGMC which was held on 25.04.2018.
5. University's Notification No. GGSIPU/Admissions/2018/2177 dated 28.03.2018 regarding Schedule of 1st Round of Counselling for admission in PGMC which was held on 04.04.2018 and 05.04.2018.

Schedule :-

6. With regard to Point 2. above, i.e. 'Revised Percentile and Cut Off Score', the following is informed:-

(a) The eligible candidates consequent to the Revised Percentile and Cut Off Score or otherwise (as explained in succeeding paras), must submit the application in physical form, together-with a copy of Challan of applicable fee of Rs.1000/- (one thousand only) payable in cash (to be deposited during banking hours in Indian Bank, Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi). The same shall be submitted in C Block Seminar Hall, Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi from 10.00 AM to 2.30 PM on 09.05.2018. Subsequently, the 'Registration of Counselling and Verification of Documents' shall be done on the same date in respect of these new

candidates. It is informed that the 'Registration for Counselling and Verification of Documents' is mandatory. The prescribed form for submission is attached as Annexure-1.

For 'Documents required' and 'Fee to be paid at the time of Counselling', the candidate shall refer to the Schedule of 1st Round of Counselling i.e. No. GGSIPU/Admissions/2018/2177 dated 28.03.2018.

For applicability / admissibility of Reserved Category Certificates, the candidates shall refer to the provisions of Admission Brochure 2018-19.

(b) Only the candidates, who have passed MBBS from the affiliated medical colleges of Guru Gobind Singh Indraprastha University and must have completed one year compulsory rotatory internship on or before 30th April 2018, are eligible to apply. The candidates who had already registered on 04.04.2018 need not register again.

(c) The candidates who applied earlier within the notified date, but were, shown as 'Not Eligible' in the merit list, need not apply again. Such candidates are eligible upto the extent of 'Revised Percentile' and 'Cut Off' scores. However, these candidates shall come for 'Registration of Counselling and Verification of Documents' from 10.00 AM to 2.30 PM on 09.05.2018.

7. With regard to 1. above i.e. Order of Hon'ble Supreme Court of India dated 03.05.2018, in the Writ Petition (C) No. 357 of 2018, titled "Rachit Sinha & Ors. Vs Union of India & Ors", it is informed that para 9. of the said Order states that ".....we direct that such States and Deemed/Central Institutions shall conduct the second round of Counselling again after reversion of the unfilled seats in the second round of Counselling of the All India Quota..."

Hence, the 2nd Counselling of Counselling, which was held on 25.04.2018 stands cancelled in accordance with the directions of Hon'ble Supreme Court of India, as mentioned above.

8. It is informed that the Seats from All India Quota have been reverted and shall be included in this Second Counselling. Vacancy position, calculated after taking into account the withdrawals after 1st Round of Counselling, unfilled seats after 1st Counselling and All India Quota reverted seats, shall be displayed at the time of counselling.

9. It is mandatory for the candidates that they either have registered on 04.04.2018 or register for counselling and verification of documents on on 09.05.2018 as explained above in para 6.

10. Admissions, during the 2nd Round of Counselling, shall be carried out in accordance with the procedure laid down in the Chapter 10, Part A, Admission Brochure 2018-19 (page 63 & 64).

11. Fees to be paid at the time of counselling: A candidate, who is allotted a seat, will be required to pay Rs. 28500/- (i.e. Rs. 27500/- and Rs. 1000/- NON-REFUNDABLE Counseling Participation Fee) on the spot, at the time of counseling. The fee will have to be paid in the form of Demand Draft in favor of "Registrar, Guru Gobind Singh

Indraprastha University" payable at Delhi. Balance fee, if any shall be paid, directly in the allotted college after admission.

12. For, 'documents required at the time of counselling', candidates are required to please refer to Clause A. (ix) of the first counselling schedule.

13. The last date for joining the allotted candidates, in respect of the candidates taking admission / also those who shall change their college and/or specialization in 2nd Round of Counselling is 12th May 2018.

14. All the admissions are provisional. The candidates may undergo biometric verification to be carried at the respective allotted medical colleges.

15. **DATE AND TIME OF COUNSELLING**

(A) **New Registration for Participation in Counselling and Verification of Documents** (as explained above)

As mentioned above in Para 6.

(B) **Allotment of Seats**

10.00 AM onwards on 10.05.2018 in the University Campus

Phase 1. Vacancies arising on account of withdrawal and due to non-joining of the candidates within the stipulated dates, shall be filled in this phase. The seats shall be offered to the same category candidates merit rank-wise till all eligible candidates of that category are exhausted.

Subsequently the resultant vacancies so created and the unfilled vacant seats of 1st round of counselling, shall be offered to the registered candidates who had not opted or allotted any seat during the 1st Round of Counselling and also, those registered candidates, who were absent during 1st Round of Counselling will also be eligible.

Phase 2. The resultant vacancies of Phase 1 shall be merged with the All India Quota reverted seats and offered in the order of merit on the 200 point roster. All the registered candidates shall be allowed to participate in the order of merit.
