The NEET UG -2017 qualified candidates who have registered in GGSIPU (for admission in B.Sc. Yoga in the Guru Gobind Singh Indraprastha University) and whose names appeared in the merit list displayed on University website, shall report in person for Verification of Documents and Allotment of Seats, at the venue of counseling, on the date and time mentioned below as per their Category and Rank.

#### Seat Allotment will stop as and when the vacancies are filled up.

Admissions in programme B.Sc. Yoga will be done on All India Basis in the order of merit.

\* Allotment on the horizontal seats shall be carried out as per the guiding lines given in the following paras.

#### Important:

- A candidate belonging to any sub-category is also eligible to secure admission in General / Unreserved Category
  of his/her respective Region, purely on the merit of CET.
- The Defence and PWD reservation shall be in all categories in a horizontal manner. If the seats of these subcategories (i.e. UR-DEF, SC-DEF, ST-DEF, UR-PWD, SC-PWD & ST-PWD remain vacant, they shall be reverted to the parent category during the 2<sup>nd</sup> Counselling.
- The conversion of seats reserved for SC, ST to General Category shall be done only after the completion of last counselling for the reserved categories and such conversion will be done during the 2<sup>nd</sup> counselling. However,

while converting the seats, any unfilled seat(s) reserved for ST Category will be offered to SC Category and vice versa and only after that the conversion of the reserved category seats shall be effected.

Allotment of Seats will stop as and when the seats get filled up.

# 2. Seat Allocation in Delhi and Outside Delhi Region

For clarification on Region i.e. Delhi or Outside Delhi, candidates may please refer to the Chapter 5: 'Seat Allocation', Part-A, Admission Brochure 2017-18.

#### Note:

i. The candidates who have passed the qualifying examination through Distance /Open Education system of any recognized University/Board and fail to provide the proof of his/her study centre being located in Delhi shall not be considered for Delhi region seats, and shall be considered for admission in the Outside Delhi Region.

#### 3. Reservation Policy

Candidates shall please refer to the Chapter 6: 'Reservation Policy', Part-A, Admission Brochure 2017-18.

#### 4. Eligibility Criteria for B.Sc. Yoga

Pass in 12th class of 10+2 pattern of CBSE or Equivalent with Science (Physics, Chemistry and Biology) with a minimum aggregate of 50% marks in Physics, Chemistry and Biology provided that the candidate has passed in each subject separately. A candidate also must have passed in English as a subject of study (core, elective or functional) in the qualifying examination. All candidates must appear in National Eligibility cum Entrance Test – Undergraduate of 2017 (NEET UG 2017) and qualify to be considered for admissions.

NOTE: The candidate should have attained the age of 17 years on or before 31st December of the year of his admission to the first year of the Course.

#### 5. Result Awaited Candidates

Result Awaited candidates may please refer to Clause 3.8, Chapter-3: 'Syllabus of Common Entrance Tests', Part-A, Admission Brochure 2017-18. They shall be admitted on an Undertaking, to be given at the time of counselling. The format of Undertaking is available as Appendix 5, Part-B, Admission Brochure 2017-18.

#### 6. Fee Structure for Programme

Balance fees, if any, shall be paid by the candidate directly in the respective allotted college.

#### Note:

- a) The college/institute (both Govt. as well as Self Financing institutes) will be exclusively responsible to ensure refund of security deposit to any such student(s) of their college/institute, who complete their degree.
- b) The college/institute (both Govt. as well as Self Financing institutes) will be also be responsible to ensure refund of security deposit to any such student(s) of their college/institute, who withdraw/cancel his/her admission any time during the programme.

# 7. <u>Documents Required for Verification and Allotment of Seats:</u>

- a) Bank Draft(s) of Rs. 31000/- in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s).
- b) NEET UG 2017 Admit Card.
- c) NEET UG 2017 Score Card.
- d) Copy of GGSIPU Registration Form.
- e) Four passport sized photographs (same as that in admit card).
- f) Copy of Admission Verification form (duly filled by the candidate as per Appendix 4(B) given in Part B, Admission Brochure 2017-18).
- g) Preference Sheet (duly filled by candidate as per Appendix 7 given in Part B, Admission Brochure 2017-18).
- h) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)



- i) Mark-sheets / Certificates of qualifying examination:
  - The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- j) Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-B in Admission Brochure 2017-18 (As per Appendix 6).

- k) Reserved Category Certificate:
  - All reservation category candidates who are seeking admission in reserved category in SC / ST / DEF / PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category.
- l) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- m) Application regarding age or any other relaxation with necessary approval (if necessary).
- 8. <u>Seat Matrix</u>: To be displayed at the time of counseling.

Vacancy Available for 2nd Counselling will be displayed at the time of Counselling/ Admission.

#### Note:

- 1. If the seats of these sub-categories (i.e. UR-DEF, SC-DEF, ST-DEF, UR-PWD, SC-PWD & ST-PWD remain vacant during the first counselling, they shall be reverted to the parent category during the 2<sup>nd</sup> Counselling only.
- 2. The students, who have been admitted during 1<sup>st</sup> counselling, in any category, will not be allowed to change their category in the subsequent counselling.

# 10. Procedure for 2<sup>nd</sup> Counselling/Admission:

- a. A candidate, who has taken admission at the time of 1<sup>st</sup> counselling, and then he / she withdraws his/her admission will not be considered for admission in the 2<sup>nd</sup> counselling.
- b. The Second Counselling will commence from rank 1 (one) onwards for all categories / programmes and the seats will be allotted strictly on the basis of merit of the candidates. Such candidates, who were absent in the First Counselling are also permitted to attend the second counselling as per their rank.
- c. A candidate who fails to appear in person on the notified date and time for counselling, shall forfeit his/her claim for the seat which could be offered to him/her, had he/she been present on his/her turn. However, if the candidate reports late during the process of counselling, he/she may be considered for allotment of a seat available at that point of time of his/her reporting.
- d. The students who take admission in the 1<sup>st</sup> counselling would not be permitted for change of a programme for which a separate Entrance test has been conducted by the University. Category change will also not be allowed in 2<sup>nd</sup> Counselling.
- e. Admission will be made strictly on merit basis (Rank-wise) and counselling/admissions will stop when all the seats get filled-up. Notice regarding closure of counselling will be displayed on University's Website. Parents/candidates are advised to check University's Website before coming for counselling. University will not be responsible for any inconvenience caused to parents/candidates due to closure of the counselling prior to date & time notified in the Counselling Schedule.
- f. A candidate, who fails to exercise the option in person during 2nd Counselling, shall forfeit his/her right for a vacant seat even if he or she had higher rank, for which the University will not be responsible.
- g. Further, the students, who have been admitted during 1st counselling in any category, will not be allowed to change their category in 2nd counselling.
- h. The students having taken admission in second counselling would not be allowed to change the programme/institute in the subsequent days of 2nd Counselling. In the interest of the students, it is advised that they should carefully select the programme/institute before taking admission in the second counselling.

Hair

- i. The candidates are also advised, in their own interest to check the details of fee, their name, rank, programme, institute of admission, etc. on Admission Slip issued to him/her by the Admission Officer before leaving the counselling hall. Provisionally admitted candidates are further advised to carefully check suffix (p) to their enrolment number printed in the Admission Slip.
- j. The conversion of seats reserved for SC, ST to General Category shall be done only during the 2<sup>nd</sup> Counselling. While converting the seats during 2<sup>nd</sup> counselling, any unfilled seat reserved for ST Category will be offered to SC Category and vice versa and only after completing this exercise, the conversion of the reserved category seats to general category shall be effected.

#### 11. Open House Counselling:

Counselling on the Open Day will be held only if any seat(s) remains vacant. The said seat(s) will be offered on this day to the qualified candidate(s) in order of merit as per his/her Region provided he/she has not taken admission till then in this programme and has reported for counselling on this day.

Even then, if any seat(s) remains vacant, the same shall be offered to the qualified candidate(s) in order of merit irrespective of his/her Region provided he/she has not taken admission till then in this programme and has reported for counselling on this day.

In the Offline Counselling, Seats reserved for Outside Delhi Category will be converted to Delhi Category and Vice versa for the programmes for which offline counselling will be done during the Open House Counselling (which will only be held if seats are vacant after 2nd Round of Counselling has been completed in the respective region). Thereafter, seats remaining vacant shall be converted into general category.

#### 9. Withdrawal of Admission

All the refund applications shall be processed in accordance with the Refund Policy 2017-18, notified by the University vide its Notification, No. GGSIPU/ Admissions/2017/19103 dated 1.3.2017. The same is available on University website www.ipu.ac.in. All the candidates are requested to note the same and withdrawal will be carried out accordingly. The refund shall be processed as per the notified Refund Policy 2017-18 of the University. All the requests for withdrawal of adminisional of administration of the University.

withdrawal of admission shall mandatorily be submitted in the prescribed format available in Part B, Admission Brochure 2017-18, (Appendix-8). The same shall be submitted in the Admissions Branch, Administrative Block, Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi – 110078. A proper receipt for withdrawal will be issued in lieu thereof. It is once again informed that the request for withdrawal has to be made in the Admissions Branch, GGSIPU only and in the prescribed format necessarily.
