Item-1: To discuss the progress of placement in different USS/Affiliated Institutes.

All the TPOs present were requested to update the placement data of their respective colleges in soft and hard copy to the Cell. The data was required to consolidate the placement data at the University level for handling various governmental issues, etc. It was accepted by all.

Item-2: To discuss about the issues and problems in the placement process.

a.) It was informed by Ms. Tripti Mishra & Dr. Umesh Chadha, TPO from DIAS that number of companies do not recognize institutions for placement purpose. It was suggested that CCGPC should write letters to various companies for placement of students of affiliated colleges and the University. It was suggested that the cell may be provided with details (Contact person & Address) for sending these letters in specific cases as well in general to the listed companies.

b.) Dr. Jaspreet Kaur, TPO from TIPS expressed her concern regarding placement of Journalism students. The matter was referred to Dr Kulveen Trehan to provide support in the matter.

c.) Ms. Madhu Arora, TPO from FIMT informed that interview for common placements should be organized in the University Campus rather than

affiliated colleges to provide a neutral place for the placements. It was informed that University has some constraints in holding the same. However in order to help students, the place of interviews is kept in institutions which has largest number of participating students.

d.) Dr. Shalini Sahni, TPO from BCIPS informed that the company visiting for HR students are very few. CCGPC should invite more companies of HR to increase the placement. It was informed that all such support is extended by the respective Placement Coordinators of the USS. They were advised to remain in contact with Dr Gagandeep, USMS.

e.) Dr. Rashi Batra, TPO from GIBS informed that we should invite companies for summer internship of students. The proposal was accepted.

f.) Prof. Supriya Madan, Director from VIPS has suggested that we should organized Career Counselling Meet for students. She volunteered to guide and steer such activities for students. She accepted the same.

She also suggested to hold such TPO meet more often. It was informed that we must hold atleast once in a year but can hold more if there are issues which need it.

g.) Ms. Upasana Diwan, TPO from RDIAS informed about the joining date is a major issue for all colleges. Most of the companies are facing this problem and students missing many opportunities because the students cannot be allowed to be given NOC before the end of the session.

h.) Dr. Mandeep Singh, TPO from IITM----- requested to provide assistance for the first batch of B.Com.students. It was accepted.

i.) Ms. Renu Yadav, TPO from IIMT shared the problem regarding placement of B.Com.(Hon.) students. It was suggested to coordinate with Placement Coordinator of USMS for greater support.

j.) Sh. Alok Basu, TPO from BVCOE College has suggested that in the syllabus we should redefine syllabus for DBMS, Data Mining and Operating system. The matter was decided to be referred to the concerned Dean for appropriate action.

k.) Ms. Amrita Kaur, TPO from MBSSPA College has suggested that the placement drives should be conducted zone wise and discipline wise colleges. It was conveyed to assess the feasibility of the same.

l.) Ms. Tripti Mishra & Dr. Umesh Chadha, TPO from DIAS College has suggested that the employability assessment test should be common for all affiliated institutes so that the MOU's is same for all college under CCGPC, so that the rates would be lowest. It was informed to collect the data about the same and then take up the matter for better financial proposal.

m.) Dr. Sima Singh, TPO from DSPSR College has suggested-Project Based learning should be encouraged by the colleges for better placement. It was appreciated by all.

Item-3: To brainstorm on possible modalities for improving the placement track record.

All the members brainstorm on the following points:-

- a.) To conduct Career Counselling Lectures for students twice in a year i.e. March and Sept. every year.
- b.) To provide Industrial visit to students for better learning and developing liaison with them.
- c.) To carryout Soft Skills Development Programmes for students to help them succeed in the GDs and Interviews.
- d.) To conduct Employability test in large numbers so that every student can participate in this test and analyse their skills and take corrective action.
- e.) To Organize HR Meet to help in developing Industry liaison for training and placement of students
- f.) To conduct focussed Workshops/Seminars for students which help them in placement point of view.
- g) To put more efforts on Summer Training and Internship so that the students can prove themselves and convert the opportunity into Pre Placement Offers.
