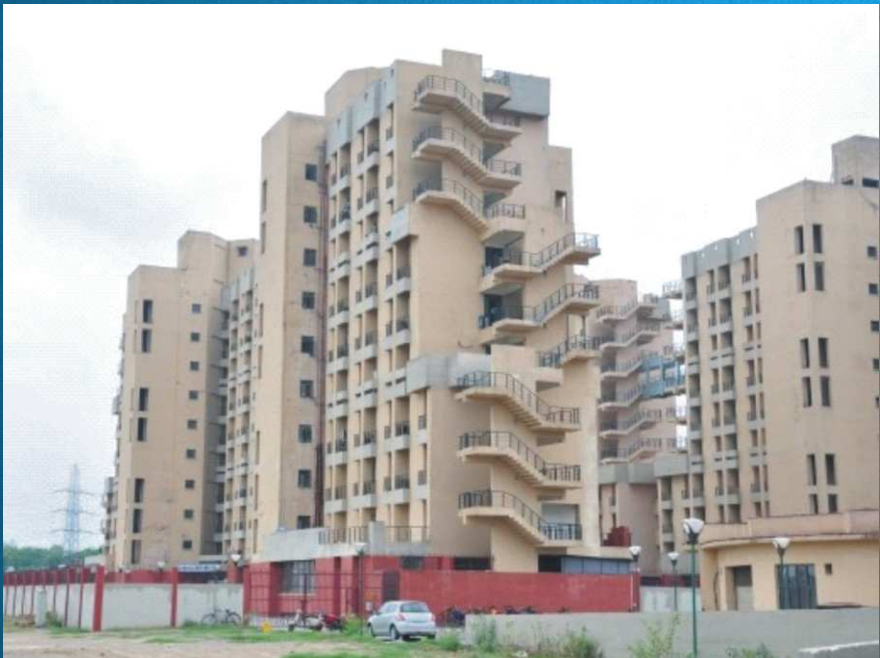

The University swimming pool is also likely to become functional in the coming season. Efforts have been

initiated to provide Medical Insurance cover to all hostel inmates. The Hostel Mess provides Breakfast, Lunch, Evening Tea with snacks and Dinner in hygienic atmosphere at reasonable rates.

The Wardens' Council makes all efforts to make hostel life comfortable and secured with the help of student representatives. The Rules and Regulations of the Hostel and Mess are detailed in the Hostel Bulletin 2015-16. We expect all the inmates to follow these Rules and Regulations in totality. Particularly, we have a zero tolerance policy towards indiscipline. University hostels are ragging free and I advise all the inmates to refrain from such activities. I also advise all the students, particularly new comers, to inform the O/o. Warden, Chief Warden and Proctor, if they notice any such antisocial activity.

I urge upon all the students to exercise self discipline so that his/her activities do not cause any inconvenience to fellow inmates. I extend my all good wishes to all the hostelers for a comfortable and memorable hostel stay. We are open to constructive suggestions from all the stakeholders for a better management of hostel affairs.

# **BOYS' HOSTELS**

## **GGs Indraprastha University**

The University maintains four hostels on campus, hostels two for the male and two for the female students of the University. The two Boys' Hostels are named Shivalik Hostel and Aravali Hostel. Each hostel has over 180 single seat rooms. Each room is equipped with basic furniture like cot, pillow, chair, table, and cupboard, tube light and fan. Each of the hostels provides mess facilities for the residents; mess is managed by students' council under the overall supervision of respective hostel wardens. The common room, gymnasium and sports facilities are also available for residents. There is a provision for round the clock water and electricity facilities for the hostels. It is concerted effort of the University to provide a wholesome hostel facility for the residents and help them pursue their respective academic and professional goals to their best. It is a consistent endeavor of the hostel administration to follow the well-established ethos of hostel life and promote a healthy community atmosphere in the hostel. Ragging, physical violence, negative discrimination, consumption of alcoholic or narcotics substances is strictly prohibited in the hostel.

### **PROCEDURE FOR ALLOTMENT OF HOSTEL ROOM**

1. All the students admitted as regular students in University Schools of Studies (USS) are eligible for hostel accommodation; however, the Outside Delhi (OD) candidates will be given priority in hostel allotment over the candidates admitted under

Delhi Category. The Allotment of hostel to the newly admitted OD students shall be done after the completion of first counseling admission process. The remaining seats will be carried over to be filled by the OD category students after 2nd and subsequent counseling. The remaining seats, if any left after the allotment to the OD category students by 15th October 2015 shall be allotted to the students from Delhi category. The allocation of seats to the Delhi category students shall be done on the following priority basis

- i) Disabled/Severely handicapped students of Delhi Quota.
- ii) According to qualifying degree merit, two lists will be prepared and the priority will be decided accordingly. First list will include students having Outside Delhi address though admitted under Delhi Quota and the second list will include students admitted under Delhi quota having Delhi residential address.
- iii) A waiting list of 10 students will be prepared in case accommodation could not be provided to all the applicants. As and when the seats will get vacant, the allotments will be done from the waiting list till 31st October. Admissions in the hostel will be closed after 1st October.
- iv) If a student does not accept the hostel allotment offered within stipulated period,



he will lose his claim and seat will be offered to the next candidate in the list.

- v) 10% of total available seat in academic year shall be reserved for foreign students and it shall be proportionally distributed across all the USS students and across the foreign national students.
2. If any seat gets vacated during the period of November 1 to June 30, the allotment will be made by the decision of the hostel committee consisting of the Chief Warden and Two other Wardens of the Boys' Hostel.
  3. The reservation norms of the University shall be followed in the initial hostel allotment in respective OD and Delhi category. The hostels seat remaining vacant in various reserved category shall be brought in the general pool, after second counseling, if there are no claimant from the reserved categories for such seats.

### **PROCEDURE FOR RE-ADMISSION**

1. All the residents are required to appear before the Hostel Admission Committee for allotment of room as per the notified schedules for the next academic sessions allowing with the following documents:
  - a. Mark sheets of the previous academic year
  - b. Requisite fee
  - c. Two recent passport size photographs along with duly filled admission form
  - d. Photocopy of students admit card and I-Card

2. If the students are detained/not promoted to the Next academic sessions because of detention or failure in the examinations are deemed to be non bonafide students and they are not entitled to stay in the hostels. They may be re-admitted if they are promoted to next academic sessions.
3. If the residents are required to clear supplementary examinations for their promotions to next academic sessions, they will be allotted room after the result of their supplementary examinations (Subject to availability of room).
4. The existing residents are required to take readmission before August 17,2015. After this date the readmission will be subject to late fine of Rupees 50 per day up to August 25, 2015. If such residents fails to take readmission by August 25,2015 their admission in hostel will be cancelled and their room will be allotted to other student. Further, at the time of readmission such residents are required to clear their all outstanding dues if any.

## **GENERAL CODE OF CONDUCT**

### **RULES AND REGULATION FOR HOSTEL RESIDENTS**

1. Hostel Residents are expected to maintain highest standards of community residency. They should be respectful towards the co-residents. Residents are expected to treat fellow residents with respect and deference. They should desist from causing threats, intimidation, verbal abuse or use of intemperate language.

2. Hostel residents are expected to be respectful and courteous in dealing with the staff and employees of the hostel administration. Any discourteous, disrespectful or obnoxious conduct with staff of the hostel administration shall tantamount to indiscipline.
3. Hostel residents are expected to cooperate with the hostel administration in conducting routine affairs of the hostel particularly those relating to safety, security, hygiene, general upkeep, peace and order in and around the hostel premises.
4. Hostel residents are expected to desist from causing damage or destruction to any hostel property.
5. Hostel residents should desist from any kind of acts tantamount to ragging, violence, harassment, nuisance, etc.
6. Hostel residents are expected to follow the rules, regulations and directions issued by hostel administration from time to time.
7. Hostel residents are expected to devote their time and energy in advancement of their academic, professional and the socio-cultural pursuits. The hostel administration shall endeavor to create suitable enabling environment for collective realization of pursuits of all residents.
8. Students are expected to attend classes regularly and maintain good academic record consistently. A student who fails in annual examination is not eligible for re-admission. A student who is detained

from appearing in University examinations or is debarred from promotion is not eligible to continue in the hostel.

9. Hostel residents are expected to follow the mess time schedule and appropriate dress norms in the mess and the public areas of the hostel.
10. Unauthorized guests in the hostels are prohibited. Hostel residents should desist from hosting any unauthorized guests.
11. Every student should bring his own blanket and linen, curtains, water buckets, jug and lock. Hostel residents are solely responsible for the care of their personal belongings, valuables and the hostel furniture allotted to them. The concerned residents shall be held liable for any damage or loss caused to the hostel furniture allotted to them.
12. Before leaving the hostel on completion of the academic session, the hostel residents should hand over possession of their rooms and the furniture allotted to them to the hostel administration and obtains a clearance certificate to this effect. A resident who fails to hand over possession may be denied re-admission in the hostel in the forthcoming academic session. A resident who do not take re-admission in the hostel after the summer vacation on or before 25th August 2014, the room allotted to him earlier may be cancelled and the possession of the said room may be taken on 'on is where is' basis without any further notice.
13. The final year residents of the hostel should

handover the possession of the room and all allotted furniture on or before 25th June 2016. Any further stay in the hostel either because of examination of any other academic reason can be permitted only with the permission of the Warden. If a final year resident fails to handover the possession of the room and allotted furniture by the scheduled date, possession of the said room shall be taken over by the hostel administration on 'as is where is basis' without giving any notice.

14. As and when the possession of the room is taken over on 'as is where is basis' the hostel administration shall not be responsible for loss of any valuables claimed to have been kept in room. The student concerned shall be responsible and be pecuniary liable for any loss or damage caused to the rooms and furniture allotted to the residents.
15. Hostel residents should keep the hostel administration informed and updated about the contact numbers, email id, and postal address of their parents' & local guardians.
16. All the important notices relating to the hostel shall be notified on the Hostel Notice board and put on the email id given by the students in their hostel application forms. Residents are expected to keep track of notices issued by the hostel administration from time to time.
17. The first year undergraduate students should not be absent from hostel without prior approval. For other students absence from hostel without prior approval

for more than three days shall constitute unauthorized absence and the concerned resident shall be liable for expulsion for such unauthorized absence from hostel.

18. Taking allotment of the hostel room without meaningful usage is prohibited. Except in exceptional cases no student shall be permitted to take leave from the hostel for more than 8 weeks in a semester.
19. Occupation of any room other than the one allotted to a resident is prohibited.
20. No student is allowed to cook inside rooms or in any other area of the hostel. The mess is compulsory for all students and all residents shall be charged for the messing facility for the period during which it is run and managed on cooperative basis. During vacations, when the mess is not run on routine cooperative basis, the residents staying during vacation shall pay and manage the mess on cooperative basis under the overall supervision of the Warden. The mess off for absence from hostel during the running academic session shall be given only in exceptional cases as per the rules notified to this effect.
21. Residents are expected to keep their rooms neat and tidy. Rooms are subject to inspect by the Warden at any time. Residents are required to maintain cleanliness of their bathrooms and corridors. Bins are provided for the collection of litter, fruit peels, etc.
22. Keeping and parking of motorized vehicles in the University premises on regular basis is permitted only with the permission of the University

administration. A request to this effect should be made to the Warden, who will forward it to the respective branch of the University for permission and university sticker.

23. The residents are required to use designated radial road for commuting in or out the university campus. Under no circumstances the Hostel residents is allowed to use road connecting library E-Block and Administrative Block for commuting in and out the University campus. Any violation of these regulations shall invite strict disciplinary measures
24. No resident is permitted to keep and host day scholars in their rooms after 9:00 PM.
25. Hosting party or any celebration inside hostel premises with day scholars will invite disciplinary measures including suspension or expulsion from hostel residency.
26. No resident is permitted to keep arms, ammunitions, heaters, immersion rods, iron, stoves, extra hostel furnitures in their rooms etc.
27. Residents should desist from causing noise, disturbance, annoyance, nuisance in the hostel premises.
28. Residents are expected to keep their rooms neat and tidy. They should cooperate in maintaining the cleanliness of corridors, bathrooms, staircases and the hostel premises in general.
29. Every room is subject to inspection any time by the Warden or any other authorized official of the

University. The residents should cooperate in inspection of their rooms as and when done. Residents are expected to conserve electricity and water. They should switch off lights, fans and water taps when not in use.

30. In normal circumstances no resident-resident shall be allowed to go out of hostel premises after 11:00PM Entry in the hostel after 11:00 PM shall be done only with the permission of the Warden.
31. Any case of physical violence, ragging, threats, intimidation, destruction of public property, theft, serious medical sickness, etc. should be reported to the hostel administration forthwith.
32. Every hostel resident is under obligation to promote community living, collective safety and security, health and well being of all co-residents.
33. Every student on leaving his room shall switch off the light and fan.
34. Hostellers are requested to take care of their own room. Hostel authority will not be responsible for any theft or missing of any items.
35. Use of alcohol or any other narcotic substance such as cigarette, ganja whether natural or flavored or other tobacco product inside the hostel premises is strictly prohibited. Any resident found using or entering the hostel premises in abbreviated conditions shall be summarily expelled from hostel residency.
36. Residents are not allowed to move out of university campus after 11.00 PM on any pretext whatsoever



except medical emergency in university ambulance. If any resident violates these regulation shall be expelled from hostel residency after informing their parents/guardian.

37. Residents are not allowed to visit terrace of hostel premises under any circumstances whatsoever or use the fire exit space for sitting in day/evening/night times.
38. Parents /guardians are required to give undertaking that their wards shall strictly abide by these regulation during their residency in hostel premises. Any violation of these regulations shall invite strict disciplinary measures including suspension or expulsion from hostel residency.

## **VISITORS AND GUESTS**

1. No visitor is allowed in the rooms of the residents except with the prior permission of the hostel administration. A resident may entertain visitor in the Visitor's Room. The visiting hours for visitors are from 5 PM to 8 PM.
2. As a rule guests are not allowed in the hostel rooms. In exceptional circumstances male guests who are in the blood relation of the resident may be allowed in the rooms for night stay only with the prior written permission of the Warden. No resident shall be allowed to entertain more than three nights of guest stay in the hostel in a month. The residents shall be required to pay Rs.300/- per day /night for a guest. If

the guests avail messing facility, the mess charges as applicable shall be payable by the resident. Hosting guest in the hostels without prior permission shall tantamount to serious act of indiscipline.

3. If any resident is allowing guests to stay in their room without prior permissions to the Hostel administrations is required to pay penal charges of Rs. 500/- per day/night. The amount so collected will be deposited in the Hostel Welfare Accounts.

### **MEDICAL CARE**

1. First aid box is available with the house secretary.
2. Any case of major illness or medical ailment should be reported to the Warden.
3. The residents shall be solely responsible for all their Health care, and medical related expenditure.
4. In case of emergency medical requirement, subject to the availability of fund in the Hostel Welfare Account, an amount not more than Rs.25,000/- may be spent by the hostel administration. Any medical expenditure made from Hostel Welfare Account shall be recoverable from the student concerned.
5. The hostel administration is in the process to introduce medical insurance for the residents to take care of mediclaim/any unfortunate mishappenings. The payment of premium and other details will be notified in due course.

## HOSTEL MESS TIMINGS

The Hostel provides for compulsory messing facility for all the residents. The day to day management of the hostel is done by the Residents' Committee under the overall supervision of the concerned Warden. Meals are served on self service basis in the Dining Halls of the respective hostels. The mess timings are as follows;

Break Fast	08:00 AM - 09:30 AM
Lunch	12:45 PM - 02:00 PM
Tea	05:00 PM - 06:00 PM
Dinner	08:00 PM - 09:30 PM

No mess furniture, utensils and materials should be removed from the dining room under any circumstances. Meals are not allowed to be taken out of the dining hall. Under exceptional circumstances in cases of major illness meals may be allowed to be carried in respective rooms.

## MESS CHARGES

Following will be the mess fee structure for the academic session 2015-16.

### MESS FEE

At the time of admission or re-admission every resident is required to deposit entire mess fee of Rs.30000/- by Demand Draft in favour of “Aravali Boys Hostel Mess Account” for Aravali Residents or “Boys Hostel Mess Account” for Shivalik Boys hostel Residents as the case may be at the time of admission/Re-admissions. The demand draft should be deposited in the office of the respective hostels. The mess charges of every month shall be displayed on the notice board and at the end of the academic session, the mess charges for the whole of the session shall be adjusted against the advance mess charge of Rs.29,500/-. The deficit, if any, shall be recovered and excess, if any, shall be returned to the concerned students.

## HOSTEL CHARGES

Following hostel charges are payable by every student seeking admission in the hostel.

### HOSTEL FEE STRUCTURE

4.	<b>Mess Security (refundable)</b>	Rs. 4,000/-
5.	<b>Hostel Welfare charges (non refundable)</b>	Rs. 3,000/-

All these charges except the hostel welfare charges have to be deposited in the accounts branch of the university through Demand Draft. The draft should be made in favour of **“The Registrar GGS Indraprastha University”** payable at Delhi. The hostel welfare charges will be deposited in the respective hostels through the demand draft made in favour of **Aravali Boys' Hostel Welfare Account** for Aravali Residents or **“Boys' Hostel Welfare Account”** for Shivalik Residents as the case may be, payable at Delhi. **The hostel welfare charge is integral component of Hostel charges and it shall be at the disposal of respective hostel warden along with student welfare secretary and it shall be used for purpose specified for expenses of welfare funds and subject to auditing like other funds of the university.**

## **RULES FOR REFUND OF HOSTEL CHARGES**

1. Any student who is allotted a seat in the hostel and later withdraws on or before 31st August will be refunded 50% of the charges.
2. Mess Security deposit will be refunded if the student has cleared his last mess bill. Clearance has to be taken from Mess Secretary/ Supervisor/Warden.
3. Hostel Security Charged will be refunded only when a student leaves the Hostel and the same must be claimed within a year of leaving the hostel. The cost of the breakage or other dues, fine imposed if any, will be deducted from the hostel security and refund may be held up if other hostel dues have not been cleared.

## **FEE EXEMPTIONS**

All the residents are required to pay the entire fee at the time of allotment of rooms in boys hostels. However, Hostel charges may be refunded to the students belonging to economically weaker sections of the society whose parental monthly income from all sources is less than threshold exemption limit as specified by DSW and who gets admission on their own merit and continue to secure more than 60% marks in University examinations. Such students have to apply to the Director, Students Welfare (DSW) for exemptions from Hostel Charges and fees will be refunded as per the existing policy of DSW followed by recommendations of the Chief Warden with the following documents.

- i. Income certificate from the parent's employer or from a Gazetted Officer;
- ii. University enrolment certificate;
- iii. Attested copy of the mark sheet of semester examinations last appeared.
- iv. Recommendation of the Chief Warden.,

The cases will be decided by the competent authority on the recommendation of the University Scholarship awarding committee.

## **WHAT SHOULD BE ATTACHED ALONG WITH APPLICATION FORM?**

1. Two passport size photographs.
2. Photocopy of the admission fee receipt (only for new students)
3. Last year Mark sheet (Only for existing students).
4. Undertaking by the parents.
5. Permanent address proof of the candidate.

## APPENDIX I

### **UGC REGULATIONS ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS, 2009 (Under Section 26 (1) (g) of the University Grants Commission Act, 1956)**

Ragging is totally prohibited in Guru Gobind Singh Indraprastha University. The following acts constitute ragging:

1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
2. Indulging in rowdy or undisciplined activities by any student or students which cause or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
4. Any act by any senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.



6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
7. Any act of physical abuse including all variants of it; sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
8. Any act or abuse by spoken words, emails, post, public insults which would also include deriving prevented pleasure, vicarious or sadistic thrill for actively or passively participating in the discomfiture to fresher or any other student;
9. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

### **ADMINISTRATIVE ACTION IN THE EVENT OF RAGGING**

The university shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under:

- a) The Anti-Ragging Committee of the university shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.

- b) The Anti-Ragging Committee may, depending on the nature of gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely;
- i) Suspension from attending classes and academic privileges.
  - ii) Withholding / withdrawing scholarship / fellowship and other benefits.
  - iii) Debarring from appearing in any test / examination or other evaluation process.
  - iv) Withholding results.
  - v) Debarring from representing the university in any regional, national or international meet, tournament, youth festival, etc.
  - vi) Suspension / expulsion from the hostel.
  - vii) Cancellation of admission.
  - viii) Rustication from the university for period ranging from one to four semesters.
  - ix) Expulsion from the university and consequent debarring from admission to any other university for a specified period. Provided that where the persons committing or abetting the act of ragging are not identified, the university shall resort to collective punishment.

## APPENDIX II

### **RULES REGARDING MESS-OFF (W.E.F. ACADEMIC SESSION 2015-16)**

1. The students residing in hostel are compulsorily required to avail the mess facility as per the hostel admission brochure. Therefore, the residents visiting their home on weekend are not entitled to any mess-off.
2. However, if some residents are required to visit home on occasion of festivity, interview or examination outside the university or any other unforeseen contingencies may be given mess-off subject to following conditions:
  - i) The residents are required to give prior intimation in writing to warden office.
  - ii) The absence from hostel must exceeds for more than 7 days in continuity.
  - iii) Such residents will be entitled to mess-off of 70% of bill amount for the period of absence subject to minimum of Rs. 50/- per day.
  - iv) If final year residents or residents because of medical reasons are not availing mess facilities for entire semester, they are required to pay 30% of mess charges as overhead expenses.
  - v) If the students/residents give application for mess off for the entire month/semesters and at the same time avail the mess facilities without information have to pay mess bill for the entire month and their previous applications for mess- off stands cancelled.
  - vi) The overhead expenses will form the part of corpus of hostel mess a/c which will be used for payment of salary of mess workers in month of June/July. Such amount will not be used for subsidizing the mess bill of residents of hostels who were availing mess facilities.
  - vii) All the disputes regarding mess-off will be resolved by the Warden in consultation with the Mess Committee.
