
The Guru Gobind Singh Indraprastha University was established by the Govt. of NCT in 1998 under the provisions of Guru Gobind Singh Indraprastha University Act, 1998 read with its Amendment in 1999. It is a teaching and affiliating University with the explicit objective of facilitating and promoting studies, research and extension work in emerging areas of higher education with focus on professional education.

University intends to hire consultation/ medical services of the medical professionals registered with IMA/DMA on per visit basis initially for three months, in the following field.
