NOTICE

In pursuance of the Statute 18 of the University, applications are invited for the recognition of teachers working in a college or institution affiliated to the Guru Gobind Singh Indraprastha University.

An authorized representative of each institution shall collect the application forms from the office of the Director, Research & Consultancy, Room No. 25, Administrative Block, contact person: Sh. Deepak Kumar, Section Officer.

The details of discipline codes and format of the application form are attached with this notice.

It is mandatory for all teachers working in any institution or college affiliated to the University to apply for the recognition. Deans/Directors/Principals must ensure that any faculty teaching in the academic session 2016-17, in the institution / college, is recognized by the University.

The qualifications and other conditions of eligibility for recognition of teachers working in a college or an institution shall be such as prescribed by the Ordinances or Statutes of the University or concerned Statutory Body.

The schedule for collection and submission of form is as follows:

1. Collection of forms on or before 8th July, 2016
2. Submission of forms on or before 22nd July, 2016

Copies of the following certificates be enclosed with the form:

- (i) Matriculation Certificate
- (ii) U.G. and P.G. marksheets
- (iii) U.G. and P.G. degrees
- (iv) Ph.D. degree
- (v) Category certificate (SC / ST / OBC / PH)

Photocopies of the certificates must be self-attested by the faculty.

It should be noted that if a teacher has already been recognized by the University, he / she shall also have to apply again together with the proof of recognition, issued previously (if any).

Deans / Directors / Principals shall also be required to fill-up the recognition form.
