Subject: Nomination of students for constitution of Students' Council 2016-17-reg.

The Students' Council is to be constituted shortly for the Academic Year 2016-17. As per the constitution of Students' Council, eight students of the University Schools of Studies are to be nominated by the Director, Students' Welfare on the basis of their performance and organizational skills in different extracurricular activities like, cultural events, programmes of various clubs under Srijan and participation & achievements in Sports etc. Academic performance of the students will not be the only criteria for their nomination to the Students' Council but also their records in respect of conduct/discipline and potential of contribution & zeal for participating in welfare activities will be considered at the time of recommendation for nomination.

Eligibility Conditions:

Only those students shall be eligible for nomination who:

1. Do not have any supplementary/back in any of the subjects of any semester/year.
2. Have no disciplinary enquiry or action taken and pending against them
3. Have not been detained from the examination for shortage of attendance
4. Have the potential to actively work for the overall development of the University

The students, who have been found indulging in acts of indiscipline, misconduct, ragging or any such activities, shall not be considered for nomination in Students' Council.

The students, who want to be considered for nomination in Students' Council, may submit an application in prescribed format alongwith copy of all previous semesters' marksheets and certificates of participation in different extracurricular activities duly forwarded by the respective Dean of USS to this effect. The application duly completed should reach in the Directorate of Students' Welfare, 1st Floor, Shopping Complex, latest by **20.09.2016 till 03.00 PM.**

It is also informed that all the students, who have submitted their application for nomination to the Students' Council 2015-16, will have to appear before the committee for personal interaction on **21.09.2016 at 2:00 P.M** at the office of Directorate of Students' Welfare. The students are advised to bring all the original testimonial, certificates/documents based on which the nomination is sought.
