Proceedings of the Meeting:

The Chairperson and the Convener of the Task Force informed the committee about the action taken by various offices [JR (E&S), all Deans, Directors, Branch Heads, DR(GA), DR(Pur.), AR (Hort.), Chairperson (Task Force), Director (Academic Affairs), DSW and Chief Warden] on the action plan already circulated to them by the task force.

Only the Chairperson (Task Force), Dean (USBT), Dean (USHSS), Joint Registrar (E&S), DR (GA) have submitted the Action Taken Report which is placed opposite at 1/c to 6/c in the file annexed as Annexure - A.

After thorough review of the women safety concern on the campus, the Committee made the following recommendations:

1. Any notification / orders related to Security / Timings of Hostel, offices, class rooms, labs may be got vetted through the Proctor and Security In-charge before they are notified.

2. Dean of the Schools and Hostel Wardens should initiate sensitization programme for the Girl Students in

general and the students of North East States of India and other countries in particular.

3. The Competent Authority may nominate 03 males and 03 females counselor from Teaching / Non-Teaching staff to interact with the students / hostellers at the designated space near health centre. The time schedule may be planned accordingly. The Dean's of USS, DSW, Branch Heads, SDC, Chief Warden may also be requested that whenever they organize the programmes related to safety for women's and gender sensitization on the campus, their proceeding of the same may be submitted in the office of Chairperson of the Task Force.

4. Security Branch should conduct at least 03 training progammes during the academic year for girl students and female staff of the University in coordination with Crime against Women Cell, Delhi Police, Moti

Bagh, New Delhi.

5. International Women's Day (8th March), Women Safety Week, Gender Sensitization Day etc. should also be celebrated to raise awareness regarding Women's issues in every academic session.

6. Girls Common Room facility needs to be created immediately and the Estate Branch in consultation with

UWD should take necessary and immediate action in this regard.

7. In the Orientation Programme organized by respective University School of Studies in the beginning of academic session, respective schools should disseminate awareness about the safety of women on campus

among the students.

8. In order to effectively monitor the scope and significance of gender sensitization initiatives on the campus, it is imperative that the Task Force be headed be Senior Women Professor of the University. The committee unanimously proposed the Chairperson University Complaint Committee, Prof. Anubha Kaushik, be nominated Chairperson of the "Task Force and the Safety for the Women on the Campus". The Committee may be re-constituted, if required.
