## CIRCULAR

### Subject: Proforma for Recognition as Ph. D. Supervisor

As per Clause 8(b) of Amended Ordinance 12: Governing Programmes leading to degree of Doctor of Philosophy which reads "(i) Any regular teacher of the University or a recognized teacher working in an affiliated college of the University who holds a Ph.D. degree and has a teaching/research experience of not less than 3 years (after obtaining Ph.D.) shall be eligible to be a supervisor or a joint supervisor. The teacher has to have established track record of research work with minimum of 08 published research articles in referred national/ international journals and is continuously involved in demonstrated research activities/ consultancy assignments / technological advancement / carries to his /her credit registered patents."

It is proposed to prepare a database of recognized supervisors which has the approval of School research Committee. The data related to research and consultancy will be available in DRC.

Hence, I request that this circular along with attached Form may be circulated to the faculty members of USS, affiliated Colleges and recognized research centers for providing the relevant details. Your kind cooperation and support in the process of preparation of the data base of recognized supervisors of G.G.S.Indraprastha University is solicited. While providing the details, care may be taken to give full and correct details. This will help to promote R & D activities of the University.

I shall be grateful if the Deans/Heads arrange to send the consolidated details both in the form of a Hard copy and a Soft copy. The information should reach to the Director Research & Consultancy by  $10^{th}$  December 2009.
