The sealed Bids will be opened at 11.30 a.m. on the same day in the presence of Bidders or their authorized representatives if any.
- 2. Bids received after the stipulated date and time will not be entertained.
- 3. Interested parties may submit their highest price for each Old University Vehicle individually in a sealed cover. The highest bidder will be identified for each Old University Vehicle separately.
- 4. The bidder should enclose an E.M.D. for an amount as specified in above table in the form of Demand Draft in favour of "Registrar, Guru Gobind Singh Indraprastha University, Dwarka, Sector 16 C, Delhi", payable at Delhi with the Quotation bid and cost of tender Rsd.500/- in the form of Demand Draft in favour of "Registrar, Guru Gobind Singh Indraprastha University, Dwarka, Sector 16 C, Delhi", payable at Delhi with the Quotation bid.
- 5. Bids without E.M.D. will be **summarily rejected.**

- 6. All the bidders are required to submit attested photocopy of their Voter Identification card / Ration card / Aadhaar Card / Driving License / Passport along with Quotation form for photo identification and address proof.
- 7. a) The successful bidder should pay the sale value quoted and pick up the Old University Vehicle on the spot at their own expense. The successful bidder must bring adequate cash with him/ herself for this purpose.
- 7. b) The successful bidder will transfer the Old University Vehicle in his/her name within 45 days from the date of dispatch of the Old University Vehicle and give the affidavit Annexure 'A'. The successful bidder will also be responsible for getting the Registration Certificate of the Old University Vehicle transferred in his / her name at his own cost expeditiously. The University will not be responsible for any lapse on his / her part in this regard.
- 8. The E.M.D. of the successful bidder will be returned only after clearance / Transfer of the old University vehicle as per the terms and conditions of the quotation.
- 9. In case same price is quoted for any Old University Vehicle by more than one eligible bidder, the successful bidder will be decided by draw of lots (Lottery) on the spot by the Committee.
- 10. The Bidder may, before submission of the bid, inspect the Old University Vehicle physical between 23/12/2013 to 01/01/2014 between 11.00 a.m. to 1.00 p.m.. No claim about quality, quantity, description and the value of Old University Vehicle sold will be entertained under any circumstances after the bids are finalized and no complaints will be entertained on this matter. The disposal of Old University Vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this University.
- 11. The University reserves the right to reject all or any of the bids, at its discretion, without assigning any reason whatsoever and the decision of the **Registrar**, **Guru Gobind Singh Indraprastha University**, **Dwarka**, **Sector 16 C**, **Delhi** in this regard will be final and binding on all the Bidders.
- 12. If the bid is submitted by a firm, it shall be signed in the partnership name, by a partner of the firm, who shall sign the bid and shall also write the names and addresses of each of the partner. If the bid is made by an individual, it shall be signed with his full name and furnish his present postal address.
- 13. If the highest quoting firm / bidder fails to honour the bid; the bid will be cancel & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the price offered by the H-1 party. In case of any dispute, decision of the Registrar shall be final & binding on the tenderer.
- 14. In case the offer is withdrawn by any tenderer at any stage, the earnest money deposited by him/her shall be forfeited.
- 15. Bidders should ensure that there is no overwriting. Cutting / Correction in the bid form. Such bids are liable to be rejected at the discretion of the University.

- 16. The successful bidder is responsible for all acts done either by him, by his servants or representatives for the clearance/removal of the Old University Vehicle bided by him / her.
- 17. The bidders shall be responsible for furnishing any false or wrong information and the consequences or loss thereof.
- 18. All legal disputes shall be subject to Jurisdiction of Delhi Courts only.
