AS PER THE RULES AND REGULATIONS OF THE USIT ALUMNI ASSOCIATION, GGSIP UNIVERSITY, NOMINATIONS ARE INVITED FOR ELECTION TO THE FOLLOWING **POSITIONS** FOR A PERIOD OF **TWO YEARS (2009-11)**:

- PRESIDENT: **ONE**
- SECRETARY: **ONE**
- TREASURER: **ONE**
- EXECUTIVE MEMBERS OF THE MANAGING COMMITTEE: **FOUR**

**ELGIBILITY CRITERIA:**

ONLY REGISTERED MEMBERS OF THE USIT ALUMNI ASOCIATION ARE ELGIBLE TO CONTEST AND VOTE.

STUDENTS WHO HAVE NOT YET COMPLTETED THEIR COURSE OF STUDY OR NOT REGISTERED AS ALUMINI FROM USIT ARE NOT ELIGIBLE TO FILE NOMINATIONS AND VOTE.

**ELECTORAL COLLEGE (WHO CAN VOTE):**

ONLY REGISTERED MEMBERS OF THE USIT ALUMNI ASOCIATION TILL JANUARY 2009 ARE ELGIBLE TO VOTE.

STUDENTS WHO HAVE NOT YET COMPLTETED THEIR COURSE OF STUDY FROM USIT TILL JAN 2009 ARE NOT ELIGIBLE TO VOTE.

**HOW TO FILE NOMINATIONS:**

NOMINATIONS BY AN INDIVIDUAL MEMBER IS TO SUBMITTED IN THE ENCLOSED PROFORMA AND SHOULD REACH THE RETURNING OFFICER, DR. ANIL K SAINI, PROFESSOR, UNIVERSITY SCHOOL OF MANAGEMENT STUDIES, GGS INDRAPRASTHA UNIVERSITY, KASHMERE GATE, DELHI-110403, THE ENVELOPE CONTAINING THE NOMINATION FORM MUST BE SUPERSCRIBED AS 'NOMINATION FOR USIT ALUMNI ASSOCIATION - 2009'.

**THE NOMINATIONS CAN ALSO BE SUBMITTED THROUGH E-MAIL ALONGWITH ALL THE NECESSARY ENCLOSURES AT [AKSAINI@REDIFFMAIL.COM](mailto:AKSAINI@REDIFFMAIL.COM)**

THE NOMINATION FOR EACH POSITION SHOULD BE PROPOSED AND SECONDED BY TWO DIFFERENT ELIGIBLE VOTING MEMBERS. A MEMBER CAN PROPOSE OR SECOND ONLY ONE CANDIDATE FOR A SINGLE POSITION. HOWEVER A MEMBER CAN PROPOSE OR SECOND A MAXIMUM OF SIX MEMBERS FOR MEMBERS OF THE MANAGING COMMITTEE. THE PROPOSER OR

SECONDER HIMSELF MUST NOT BE A CANDIDATE HIMSELF FOR SAME POSITION.

EACH CANDIDTE ALONGWITH THE NOMINATION FORM MUST ALSO SEND A BRIEF PROFILE AND THE STATEMENT OF INTENT, IF ELECTED. (NOT EXCEEDING 150 WORDS)

CANVASSING IN ANY FORM DIRECTLY OR INDIRECTLY IS PROHIBITED.
