

- List of admitted candidates indicating Student Name, Father's Name, Date of Birth, NLT Rank/CET Rank and % percentage of qualifying examination (Aggregate % should be strictly as per eligibility criteria mentioned as per rules).
- Copy of Advertisement of Admission Notice published in at least two leading daily newspaper, one in Hindi and other in English in addition to display of the same on Institution Notice Board etc., as mentioned in the Notification dated 14.06.2007.
- Personal file of the admitted candidates containing Application form, Admit Card, copy of NLT Rank Card/CET Rank Card and all other documents as required for admission alongwith supporting documents.


