3. Key Principles

We look forward to follow Reduce, Reuse and Recycle and work towards - Reducing emissions and water intake, Efficient systems and process, disposal of toxic and hazardous wastes, Use of renewable energy sources, etc.

Social Responsibility: The University seeks to support suppliers who demonstrate commitment to ethical labor practices, including fair wages, safe working conditions, and diversity and inclusion. We understand that our operations not only affect our own communities but also of those who are our suppliers. Therefore, we encourage our suppliers to undertake steps to collaborate and associate with the local community for economic and social development by providing employment, helping in eradicating poverty, helping in developing skills of local people etc.

We expect our suppliers to adopt robust and relevant business practices in order to comply with applicable health and safety laws, rules & regulations and best industry standards. We also suggest suppliers to take reasonable actions to prevent accident and injuries by minimizing risk situations.

Economic Viability: While pursuing sustainability goals, the University recognizes the importance of achieving value for money in procurement decisions. We strive to balance sustainability considerations with cost-effectiveness, seeking opportunities to invest in long-term sustainability solutions that deliver economic benefits. Suppliers must comply with applicable local and international laws to promote free and fair competition in procurement and to get business by offering competitive prices and innovative products and services.

In alignment with our sustainability objectives, the University will consider the Sustainable Procurement Criteria when evaluating suppliers and purchasing goods and services.
