NOTIFICATION

The Board of Management of the University in its 92nd meeting held on 03.08.2026 vide Agenda Item No. 92.20 considered and approved following amendment in the clause (v) 'Age Limit' of the Ordinance 14 related to Appointment on Contract Basis or equivalent. The amended provisions are as under:

Clause No.	Existing Provisions	Approved Amendment
(v)	Age limit: The age limit for Assistant Professor and above will be 70 years. If age permits they may be initially appointed for a period of 3 years extendable by another period of 2 years till they attain the age of 70 years. However, the appointment would be on year to year basis. In the case of other staff at the level of Assistant Registrar and above the age limit will be 70 years; however, the age limit at the time of first appointment in case of other staff will be 45 which will not be applicable at the time of renewal of contract.	Age limit: The age limit for Assistant Professor and above will be 70 years, if age permits, they may be initially appointed for a period of 3 years, which is further extendable on year to year basis till they attain the age of 70 years. The age limit, at the level of posts Assistant Section Officer and above, will also be 70 years. However, the upper age limit at the time of first appointment on the above referred post of other person on contract will be 45 years, which will not be applicable at the time of renewal of contract. Provided further that the minimum age, in case of employee retired from the departments/ institutions prescribed in the RRs shall be 45 years and above at the time of initial appointment which will not be applicable at the time of renewal of contract.

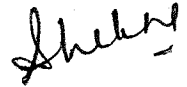
